

1990 Meeting in Raleigh—Don't Miss It!

If you have not registered for the annual meeting and national Alford family reunion in Raleigh, NC, October 12-14, you should do so immediately! So far 41 primary members and 22 of their spouses have registered from

about 15 different states. These members are listed at the end of this article. Most of the planning for the meeting is being done specifically for those who have registered. It is not absolutely necessary to register in advance (although it will cost more to register on site in Raleigh), but the plans being made may not address your Alford interests if you don't preregister. You can register by sending \$25 per person to AAFA. This fee pays the food expenses of the reception and breaks.

The meeting will begin with an informal (casual dress) reception at 6:00 P.M., Friday, October 12. There will be light refreshments and a cash bar. The business meeting will begin at 9:00 A.M. Saturday morning, and as quickly as business can be completed we will move into activities dealing with our Alford ancestors. This will continue through the afternoon. There will be coffee breaks in the morning and afternoon.

Saturday evening there will be a dinner, or mini-banquet, for those who wish to pay the extra cost of the meal—you'll have to eat someplace and this will not be extravagant.

Sunday morning thère will be State-oriented work groups where those interested in Alford ancestors from one particular state or another can meet together to discuss their problems and look over AAFA information on the Alfords of those states. To the extent that State Representatives are able to attend, it is planned that they will "host" their respective tables. A coffee break is planned for Sunday morning.

Efforts are being made to arrange a tour of some Alford historic sites in Wake County, and possibly a tour of Franklin County. Those registered have been, or will be, contacted to determine their interest in the tours.

The Holiday Inn Raleigh North is providing us rates of \$44 single and \$49 double. Make reservations by calling 919-872-7666. This is the direct line to the hotel. It is best if you do not call the Holiday Inn central reservations system as they do not know about our arrangements. Please note a change of address for the hotel from 2815 North Boulevard to 2815 Capital Boulevard—the street name has been changed. After registering you will receive specific instructions on how to find the hotel. If you prefer not to stay at the Holiday Inn, you can find many other facilities available. If you're flying, remember that Delta Air Lines, Inc. is giving AAFA members a discount. Make arrangements by calling 800-221-1212, ask for the Special Meetings Network and give them file number L33016. Do check with your travel agent as well—you may be able to get a better fare.

Membership Growth

In the previous issue we began the practice of showing three graphs to give members some appreciation of what's happening with the membership. The format of the charts has changed slightly.

The AAFA Growth or Quarterly Membership Additions Chart has been revised to show the number of new members each quarter, and stacked on top of the new members is a much smaller bar that shows the number of members who have failed to renew in some quarters. Continued growth depends upon you and other members. Renew your membership! We need your support. And if you can, recruit a new AAFA member.

The chart showing AAFA Members by State continues to list all states with three or more members. There is some change since the previous report because members who failed to renew were not counted in this tabulation. Alabama moved from position 12 to 8 and Virginia eased ahead of Missouri. Oregon and Colorado dropped completely out of the tabulation. Get with other Alfords and Alford descendants in your state and see about getting your state into the race. It is possible to overcome Texas, but it isn't going to be easy!

If you've had trouble translating the code used to identify the various branches of the family, the following will provide more identification. Notice that several of these Alfords were sons or grandsons of James Alford, who was featured as the Ultimate Ancestor in this issue.

JUL717VA is Julius Alford, son of James, born 1717 in Virginia.

JUL747NC is Julius Alford, son of Lodwick, grandson of James, born about 1747 in North Carolina.

LOD740NC is one of the Lodwick Alfords, probably Lodwick Jr. son of Lodwick and grandson of James.

JAC738VA is Jacob Alford, son of Lodwick and Susannah Alford, born 1738 in New Kent County, Virginia.

THO585EN is Thomas Alford born about 1585 in England. He was an ancestor of the brothers Benedict Alford and Alexander Alvord who came to Boston in the first half of the 17th century.

JAM713VA is James Alford born 1713 in Virginia, son of James Alford. This is not a proven connection and we may eventually connect this branch of the family to a different early ancestor.

JAM741NC is James Alford born 1740 or 1741 in North Carolina (maybe Virginia), the son of Lodwick Alford and grandson of James Alford.

JOH696MD is John Alford who may have been born 1696 in Maryland. Some think he was born in England. He died 1748 in Virginia.

Keep Your Membership Current!

Did you get a renewal notice with this issue of AAFA ACTION?

If you did, send in your renewal now, while you're thinking about it!

It helps AAFA keep its books straight if you do it on time and keeps our cash flow in the black. **ROB760EN** is Robert Alford born 1760 in England. He and his son David settled in Alabama.

WIL734VA is William Alford born 1734 in Virginia. This is another iffy connection, and while some believe William was the son of Lodwick Alford, this has not been proven.

HAY780GA is Haywood Alford born about 1780 in Georgia.

ISH749NC is Isham Alford born about 1749 in North Carolina and supposed to be a son of one of the Lodwicks.

JOH800NC is one of several John Alfords born about 1800 in North Carolina—family settled in Mississippi.

ARC780NC is Archibald (Baldy) Alford, born about 1780 in North Carolina—family settled in Alabama. [See article on him in this issue.]


HIN827NC is Hines Berry Alford of Franklin County, NC—born 1827. He is the first of those listed who remained near his place of birth for his complete lifetime.

THO802VA is Thomas Alford, born 1802 in Virginia. His family settled in Oregon.

WIL751NC is William Alford of western North Carolina. He may have been born in Virginia and later moved to North Carolina.

Here's a great idea: Get your cousins signed up—then use the occasion of the annual meeting to stage a mini family reunion for your branch. At the meeting in Raleigh there will be brothers and sisters from Texas, Louisiana, Massachusetts and probably California. They also used the meeting in Houston as an occasion to get together.

There is one exception to the following being new members. R. A. Alford, member # 119, is not a new member. We were saddened to learn of the sudden death of Robert R. "Bob" Heard who passed away at 3:00 pm on 4 June 1990 while fishing with a friend in Ccdar Hills Lake, Madison County, Mississippi. Bob was the husband of Ruby Alford Heard, AAFA Mississippi State Representative. Bob was more than just a name to a large number of the members. Many members have had the privilege of visiting with the Heards over the years and knew Bob personally. Although he did not actively research Alfords, he made it possible for Ruby to do extensive work in that area and supported her in all her genealogical endeavors.

Bob was born 22 July 1925, in Brookland, Arkansas, the son of Ezra Mack and Lena (Lawrence) Heard. He was the youngest child of the family with an older sister, Vaudine Heard Dickinson, who resides in Florissant, Missouri; and three brothers, Deward, Purvis, and David, who preceded him in death.

Bob enlisted in the United States Marine Corps at the age of 17 during World War II. He was stationed in the Pacific and was wounded on Iwo Jima. After a period of rest and recuperation he was sent to the Volcano Islands until he was sent home and discharged in February 1946.

He and Ruby were married 20 April 1968 in Downey, California, the second marriage for both of them. Bob worked with Loomis Armored Car Service for many years and then went into the business of making plastics with a company in Denver, Colorado. He had a heart attack in Colorado and returned to Cinifornia where he later had two more heart attacks. They continued to reside in California until 1973 when they moved to Mississippi. His severe heart condition precluded all strenuous activity and he helped pass the time by fishing.

Bob loved to fish, and through fishing he made a lot of friends. He never met a stranger and went out of his way to help folks. Ruby has been managing apartment complexes for several years and all of the residents of the complexes thought he could do no wrong and dearly loved him.

Bob and Ruby had no children, but he had three children by his first marriage. They remained with their mother.

Ruby said, "Life is so precious and none of us really thinks we will be snatched from it so fast. Life must go on but my life will never be the same anymore. No one gives up a person as good and kind as he was to me, without pain and heartbreak. May God richly bless him and I pray we will meet again in the future. I loved him very much. He may be gone but his memory and the close years we shared will always be with me. He left a void in my life that will be there forever."

Bob was buried 6 June 1990 in New Hope Cemetery, near Carthage in Leake County, Mississippi.

Our concern now is for Ruby. She needs your attention—prayers, cards, letters, phone calls, visits, etc. Few people realize how much she has done in the way of Alford research. She has helped countless people from all over the country. She has traveled and spent many, many hours doing research for which she never asks a dime. She and Bob were planning to attend the annual meeting in Raleigh in October, but she is afraid she will have to cancel that now. RICHARD EARL ALFORD

CRYSTAL SPRINGS—Richard Earl Alford, 90, a retired rural carrier, died of pneumonia Saturday at Hardy Wilson Hospital in Hazelhurst.

Services are 11 a.m. Monday at Crystal Springs United Methodist Church with burial in Poplar Springs Cemetery. Visitation is 4–6 p.m. today at Stringer Funeral Home.

Mr. Alford, born Aug. 3, 1899, five miles south of Crystal Springs, had lived in Crystal Springs since early adulthood. He was a member of Crystal Springs United Methodist Church, where for half a century he greeted the congregation at the door every Sunday, said his wife, Dorothy.

Originally a contractor, Mr. Alford spent most of his working years as a mail carrier. Along his mail route, which was more than 100 miles long, he was known as Uncle Earl to the children to whom he passed out gum.

"He was great with all little children, not just mine," said his daughter, Carol Moore of Baton Rouge, La.

The Copiah County native was a master woodworker and ran a Jackson antique store called Alford's, a Master Craftsman. He built the first Federal Housing Authority house in Crystal Springs and had a shop in his back yard in which he created many items, including three-story doll houses built according to FHA standards with real windows and lighting. Other special pieces included two innovative cucumber graters for two agricultural experiment stations and an intricate systems piece for a bank in north Mississippi. He made household items such as bookshelves, cabinets and stereo cases.

"He did beautiful woodwork," Moore said.

He particularly enjoyed delighting his grandchildren, his wife said. He built a large playhouse for his granddaughter and a workable water mill for his grandson. He also later made fine furniture for the two.

"He was certainly a wonderful person when I was growing up, and my children felt the same way about him," Moore said.

In addition to his wife and daughter, he is survived by sisters, Mary M. Spencer and Martha Martin, both of Crystal Springs; and two grandchildren.

Alford, City Recorder of Medford and one of the early pioneers of Oregon and Jackson County, died at her home in Talent Friday, Oct 9 at 2:20 p.m. after an illness of several weeks. Mrs. Alford crossed the plains by ox team in 1850, westward bound, with friends, her parents being dead, locating in Linn Co., OR. She was married to Albert Alford in 1854 & came to Jackson Co. in 1869, locating first on the Kahler Ranch near Tolo. In 1874 she moved to Talent where she has resided & where Mr. Alford died in Oct 1921. The deceased was born in MO on Dec 24, 1838 and was 86 yrs, 9 mos & 15 days old at her death. She was a devout member of the Baptist Church in which she was active until a few years ago when her health commenced to fail. She was a devoted wife & mother & friend to everyone. Her splendid deeds of kindness from pioneer days until her death will be remembered by many people in this county. The deceased was the mother of four children: R.A. Alford of Klamath Falls, M.L. Finally, this hobby has given me the opportunity to meet (at least through correspondence, if not in person) a wide range of fellow "tree climbers" from all over the country, and I have thoroughly enjoyed my relationships with all of them over the years.

If anyone can come up with a less expensive, more rewarding hobby, please don't tell me about it; my wife already refers to this as my "obsession," rather than my hobby, so I'd better not get started on anything else that I might enjoy more!

Alfords of St. Clair County, Alabama, and Nearby Counties

[Until further proof is obtained concerning the children and descendants of Archibald and Elizabeth ALFORD, this tentative grouping must be considered conjecture only, supported by various degrees of circumstantial evidence.]

Our first suspected record in Alabama of this individual (who was probably Archibald ALFORD) is in the 1820 census of St. Clair Co. AL, where one "Bald ALORD" seems likely to be our man. He lists a total of six individuals in his household: a male and a female over 21, and one male and three females under 21. This distribution of male and female children, however, does not agree with what we will see in later censuses, where we find several males born by 1820.

The 1830 St. Clair census has two ALFORD's, whom we suspect to be father and son, and who appear on pp. 226 and 228 respectively:

Jeff ALFORD had moved to Etowah Co. by 1870, and appears there on p. 342 with only his widowed mother Elizabeth (b. 1781 GA) in his houschold. Jeff ALFORD and his wife Mary were divorced in Etowah Co. in 1866. On p. 344 of the 1870 census of that county (very near to Jeff) appear one Mary ALFORD (b. 1841 SC) and her son James W. ALFORD (b. 1864 AL). This would certainly seem to be the wife who divorced Jeff four years earlier, and their child.

In conclusion, these close relationships suggest that we might group this family in the following manner:

Bally / Baldy / Archibald? ALFORD, b. about 1780 NC and d. 1860-70, probably in Cherokee Co. AL. He married (poss. 2nd wife) Elizabeth, b. 1781-1800 GA and d. after 1870, probably in Etowah Co.

Residences: 1820-30 St. Clair Co. AL 1840 Benton (Calhoun) Co. AL 1850-60 Cherokee Co. AL 1870 Etowah Co. AL (Elizabeth)

Their probable children:

- Thomas ALFORD, b. 1800-1810 and d. after 1840 in St. Clair County. He m. 4 March 1828 in St. Clair Co. to Patsy TRUSS. Thomas is on same p. in 1840 St. Clair with Isham and Jeff. Thomas and William apparently married TRUSS sisters.
- 2. William ALFORD, b. about 1810

GA (TN?) and d. after 1880 in St. Clair County. He m. (1) 23 Feb 1829 in St. Clair Co. to Priscilla TRUSS. She was b. in 1802 in NC and d. in the 1850's. William m. (2) about 1857 to Margaret ______, who was b. in 1820 in SC and d. after 1880. William is near "Balda" in 1830 St. Clair. He and Thomas seem to have married TRUSS sisters. He is six households from Isham in 1850 St. Clair,

and six households from Richard

in 1860 St. Clair. He is not far

- from Travis in 1870 St. Clair. 3. Jefferson J. ALFORD, b. 18 March 1812 GA (TN?) and d. 4 June 1887. He m. (1?) by 1846 to Nancy Ann ALLEN (b. 1815 SC). He m. (2) about 1861 to Mary (divorced 1866). He m. (3) after 1870 to Nancy GULLEDGE (b. 1842 SC). [Buried Liberty Cemetery, Etowah Co. AL.] He is on same page in 1840 St. Clair with Thomas and Isham, and nine households from "Bally" in 1850 Cherokee. He is twelve households from Jackson in 1850 Cherokee. His apparent mother Elizabeth is with him in 1870 Etowah.
- 4. Fernaty? ALFORD. b. about 1814? and d. ?. She m. 23 Sept 1832 in St. Clair Co. to James JOHNSON. Her name is possibly used by William for his daughter, listed as "Panata" or perhaps "Naty" in two places in the 1850 St. Clair census.
- 5. Isham ALFORD, b. 1815 TN (GA?) and d. after 1860 in Sabine Co. TX. He m. 14 Aug 1838 in St. Clair Co. to Silvia Ann HODGES (b. 1824 AL). Isham is on same page in 1840 St. Clair with Thomas and Jcff. He and Richard married HODGES sisters. Isham is six households from William in 1850 St. Clair. He and Allen are 21 households apart in 1860 Sabine Co. TX. He named a son "Balldy," presumably for Isham's father.


- John ALFORD, b. 1819 GA and d. after 1870 in St. Clair County. He m. 27 Jan 1842 in St. Clair to Teressa MONTGOMERY (b. 1824 AL). John is seven households from Samuel TRUSS in 1850 St. Clair. (Samuel TRUSS was apparently father-in-law of both Thomas and William ALFORD.)
- Allen ALFORD, b. 1824 AL and d. after 1860 in Sabine Co. TX. He m. Mary (Polly) A. _____ (b. 1828 SC or GA). Between 1850 and 1860, Allen moved from Cherokee Co., AL, where Bally, Jeff, and Jackson lived, to Sabine Co. TX, where he appears in 1860 just 21 households away from Isham.
- 8. Travis C. ALFORD, b. 1825 AL and d. after 1880 when in St. Clair Co. He m. (1) Frances _____ (b. 1831 AL); m. (2) America (b. 1830 AL). These two could be the same wife. Travis has not been found in the 1850 Census. In 1860 St. Clair, Travis is next door to William's son John. In 1870 St. Clair, he is seven pages from William, and in 1880 St. Clair, Travis is in the same enumeration district as William, but seven pages away. He named his youngest son (b. 1871) Archy, perhaps for Travis' father.
- Richard ALFORD, b. 1829 AL and d. after 1860 when in St. Clair Co. He m. 23 Oct 1851 in St. Clair Co. to Louisa HODGES (b. 1834 AL). Richard is in the household of Bally and Elizabeth in 1850 Cherokee. He and Isham married HODGES sisters. In 1860 St. Clair, he is six households away from William.
- Jackson ALFORD, b. 1830 AL and d. after 1860 when in Cherokee Co. He m. (1) Jane PERRY? (b. 1831 GA); m. (2) Mary

JOHNSON? (b. 1833 GA). Jackson is twelve households from Jefferson in 1850 Cherokee, and 21 households from Bally and Elizabeth. In 1860 Cherokee, Jackson is fifteen households from Jefferson, and nineteen households from Bally. Alfords from Ireland in the IGI

Many Alfords and Alford descendants have expressed considerable interest in the "Alfords" of England, Ireland, Wales, and Scotland. With the help of Alicia Houston, AAFA Census Project Officer, we now have a complete set of the Alfords in the LDS-IGI of the British Isles. The records for Ireland are listed below.

Members will recognize a couple of new spelling variations. These may or may not be related to the "Alfords." Other spellings in the IGI which were not listed here are OL-PHERT, OLPHERTS, and ELLERFORD. If you think they are pertinent, let us know and they will be published later.

Birth Place and Married Place are not listed as they are all assumed to be Ireland. The records in the LDS-IGI were all birth, christening or marriage. The date of birth or christening is shown under the birth date. The "Event" on the right of the page distinguishes between actual birth or baptism.

The computer grouped all children under parents with identical names. It is possible that some of the parents listed could actually be different persons with the same name.

Columbus Washington Alford

The following was adapted from an article prepared by Ruby Alford Heard for publication in the Leake County (Mississippi) History.

Columbus Washington⁶ (1850-1936), James Floyd⁵ (1817ca-), Zaddock⁴ (1787ca-1823), Julius C.³ (1797-1820), Lodwick² (1710-), James¹ (1687-).

Columbus Washington Alford, known as "Lum", was the son of James F. and Sarah (ELLIS) Alford. He was born 18 January 1850 in Troup County, GA. His birth was during the short term of President Zachary Taylor who died 9 July 1850. President Taylor became ill from the heat while laying the cornerstone for the Washington Monument July 4, 1850 and died five days later. Daniel Webster was convinced that Taylor's death prevented the outbreak of the civil war in 1850.

Lum died 30 November 1936 in Freeny, Leake County, Mississippi. He is buried there in Shockalo Cemetery (New Bethel). Earlier that month Franklin D. Roosevelt had defeated Alf Landon for the Presidency.

Columbus married Martha Maryann (Mollie) D. GLOVER 17 September 1871 in Reeltown, Tallapoosa County, Alabama. This was just two months after William "Boss" Tween was exposed by the New York Times for taking up to \$200,000,000 in fraudulent contracts, kickbacks, false vouchers and other corrupt practices which brought New York to the verge of bankruptcy. It was just two weeks before Brigham Young was arrested for practicing polygamy-part of the pressure brought on by the Federal Government against the Mormons, And it was just three weeks before the fire in Chicago would kill 250 people and do damage estimated at \$196,000,000.

Maryann, the daughter of John Sanders

and Mary Glover, was born 11 August 1857 in Tallapoosa County, Alabama. She died 27 January 1944 near Estes Mill at Four Corners in Leake County, Mississippi. She too is buried at Shockalo Cemetery (New Bethel).

Columbus and his family moved from Alabama to Mississippi about 1880. They rented a home for a year after moving and then bought land in the Freeny area, giving five bales of cotton for it.

Lum was an ordained "Hardshell" Baptist preacher. He was liberated to preach in February 1897, ordained at Shockalo in May 1906 and called as pastor with elder J. R. Willis in November 1906. For the next fifteen years, he was called every November as pastor at Shockalo. He retired in 1922 due to ill health. He continued to perform marriages, preach and conduct funerals as his health permitted.

- Wilburn Whitfield "Whit" Alford, born 5 September 1875 in Tallapoosa County, AL; died 21 May 1962 and is buried at Pleasant Hill, Leake County, MS; married Virginia Amanda

- iv. Edward "Ed" Franklin Alford, born 23 February 1877 in Tallapoosa County, AL; died 16 May 1940 and is buried at Pleasant Hill, Leake County, MS; married Laura HOLLINGSWORTH 22 December 1897.

Alexander & Asahel, Revolutionary War Vets

Alexander Alford (1752–1836)

Alexander, son of Benedict and Jerusha (Ashley) Alford, was born 25 June 1752—probably in Hartford County, Connecticut, although some say he was born in Vermont. He died 13 August 1836 in Colchester, Chittenden County, Vermont.

Alexander married Elizabeth Lease on 29 August 1782 in Williamstown, Berkshire County, Massachusetts. Alexander was from Rutland County, Vermont, at the time, and the ceremony was performed by the Reverend Seth Swifft. The couple settled in Colchester, Chittenden County, Vermont. Elizabeth was born about 1765: on 8 October 1838 she stated that she was age 73. She died 18 January 1849 in Vermont.

Ale: ander enlisted in 1775 in Captain Gideon Brownson's Company in Colonel Warner's Regiment of the Green Mountain Boys and took part in the expedition to Quebec. He remained there until the retreat of the army.

He enlisted, for three years from Colchester, as a private in January or February 1777. He served in Captain Titus Watson's Company, Colonel Flemon or Heman Swift's Seventh Regiment, General Washington's Brigade, General Putnam's Division of the Connecticut line and in Continental service. He served the full period and was discharged someplace in New Jersey.

He was present on 6 October 1777 for the storming of Fort Montgomery on the North of the Hudson River on board a Row Galley called Lady Washington commanded by Captain Lewis.

Although it is not mentioned in his pension application, a DAR lineage record indicates he was in the battle at Fort Washington.

He applied for a Revolutionary War

pension 10 April 1818, and the certificate was issued 11 June 1819. He received a pension of \$8 per month. He filed a Revolutionary War claim 20 June 1820 requesting an increase in his pension because his wife was sick in bed and had trouble with her eyes. He stated he was a farmer suffering from cancer and had four children living with him. He identified the children as Daniel 12, Eliza 9, Jane 16, and granddaughter Laura Ann 4.

Upon his death in 1836 Elizabeth's pension commenced also at \$8 per month. A later record showed \$80 per year to begin March 4 1843.

The index on those in the Revolutionary War lists an Alexander who served in Captain Coffen's Company, Vermont Militia, and one who served in Captain Abraham Salisbury's Company, Vermont Militia. These two were also separate entries in a list published in THE MAGAZINE OF AMERICAN GENEALOGY, Vol.1 No. 3 (October 1929). According to this source, the

time of service of both these Alexanders was in 1781. Alexander, the subject of this article, did have two older cousins named Alexander, but they were thought to be of Connecticut. No evidence of any pensions were found for other Alexander Alfords.

If you are interested in reviewing the pension files on Alexander Alford or other Alfords, refer to National Archives Micro Copy 804-31. If you prefer actual copies of the documents, they may be ordered from the National Archives and Records Administration, 7th and Pennsylvania Avenue, NW, Washington DC 20408. You will need to write them first to obtain the appropriate form: NATF FORM 80. If you order copies of Alexander's pension record, you should cite pension number W20600.

At least one DAR line is based on the service of Alexander Alford, that of Miss Mary L. Braman #48754. If you have copies of DAR lineages in which Alfords are listed, please send a copy to the Missouri office of AAFA.

(Asahel Alford, 1761-1853)

Asahel Alford was born 1761, probably in Massachusetts. He died 25 June 1853 probably in New York. He

married Lydia _____ who was born about 1760.

Asahel enlisted in Beckett, Massachusetts, on 1 January 1776 as a private in Captain Moses Ashley's Company, Colonel John Paterson's Massachusetts Regiment. He was taken prisoner at the Cedars on the St. Lawrence River but delivered to the American army in ten days.

Asahel enlisted for three years on 1 January 1777 in Massachusetts. He was in Captain Moses Ashley's Company, Colonel Joseph Vose's Regiment, Massachusetts Line, Continental service. He served until 7 January 1780 and was discharged in Highlands on the Hudson River in New York. He took part in the battle when General Burgoyne was taken, in battles at Monmouth and Long Island. He was in winter quarters in Providence, Rhode Island, with General Glovers Brigade, Colonel Joseph Vose's Regiment.

Asahel received a pension of \$8 per month commencing 22 September 1819. At that time he was 58 years old and residing in Sharon, Portage County, Ohio.

In 1822 he identified himself as a laborer with rheumatism. He and his

wife Lydia, age 62, had living with them a daughter, Melinda, about 30 years old, who was crippled and unable to work. His deposition puts him in New York at this time.

In 1850 he was living in Columbia, Herkimer County, New York with Cyrus Alford and his wife Clarinda.

Elijah Alford, of Portage County, Ohio, signed an affidavit to support Asahel's pension claim, stating that he knew him and that they had served together. No kinship was established.

More information on Asahel can be found in Mary Coffin Johnson's THE HIGLEYS AND THEIR ANCESTRY, An Old Colonial Family, Asahel was born 22 November 1760, son of Elijah and Hannah (Higley) Alford. He had six brothers and sisters and eight children. One brother, according to THE HIGLEYS, was Elijah, born in 1757, who moved his family to Portage Co., OH. A complete account of this branch of the family (Descendants of Benedict Alford born about 1619 in England) can be found in Gil Alford's newsletter ABOUT ALFORDS, Number 31-32. Spring-Summer 1990.

The Alexander Alford Letter

Last quarter we stated plans to publish an "old Alford" letter in each issue of AAFA ACTION; beginning in that issue with one from Caroline Bridges Alford, the new bride of Alexander Alford of Copiah County, Mississippi. Alexander was the son of Sion and Catherine (McPhaul) Alford of Robeson County, NC. Alexander wrote the following letter to his father three years after his marriage. Notice that he mentions his baby daughter, Emma. In future issues you'll see letters written to Emma some seventy years later. Rockport [Mississippi] August 12, 1860

Dear Father,

I will attempt to write you a short letter. I have not much news to write you. We are all well except our little girl. She is not well. Seems to be rather puny at this time; teething I suppose. Caroline wants to have her Ambrotype taken and send it to you. She thinks hers is better looking than anyboddies babe. But I fear Emma will not sit long enough to take. She does not grow very fast.

The most disturbing news I have to write is the protracted drought. We have had no rain of consequence since the first of May. My ground has not been wet since that time. Corn is the most complete failure that I have ever seen. I will not make more than one third enough to do me. Peas and potato crops will be short and unless it rains soon they will make nothing. Cotton is

cut off half if not more. The dry weather has been general in great measure throughout the state, though in many places not so severe. I think this neighborhood has suffered as intensely as any I have heard from. It I fail to make a pea and potato crop I will have to buy about a thousand bushels of corn.

Henry is now out of employ. He has been employed up to this time tolerably constant. He thinks there is a chance to get business up as a clerk in a merchantile house on the railroad. If he succeeds he will do better business even if his wages are not so high. He will be constantly employed. His health is bad. The health of our connections here is good. Cousin Jacob Ard died last Thursday of consumption. Politics are tolerably high in Mississippi at this time. Breckenridge and Lane will carry the state by the usual Democratic majority. My own private opinion is that Lincoln will be elected. I believe I have nothing more.

Yours Affectionately, A. Alford

The Henry mentioned in the last paragraph is thought to be Alexander's half-brother Henry Giles Alford who later moved to Texas.

Don't forget to send us copies of your old Alford letters. They need not have genealogical content. Many are interesting from a human interest viewpoint, and they all have some historical significance.

Lucille is seeking information on the Andrew Alford who was listed in the 1880 census in Lamar County, Texas. He was born about 1844 in Arkansas and married a Sarah who was born about 1845 in Tennessee. She was probably a widow White as there was a 19 year old J. W. White living with the family as a stepson. All of the children were born in Arkansas except the first who was born in Texas. Their ages in 1880 suggest years of birth as follows: females S. L. 1869, N. J. 1871, L. W. 1874, E. E. 1875; males G. E. 1877, SAMUEL M. 1878 and W. A. 1879.

The 1850 census of Arkansas lists two Andrew Alfords. An Andrew J. was one month old at the time of the census, son of Peyton and Miranda Alford in Crawford County. Peyton was born about 1823 in Georgia. The other Andrew was born about 1842 according to the census. He was the son of Madison Ewing Alford and was enumerated in Pike County. Information from the family indicates he was born 12 May 1842 and died after 1910, but nothing else is known of him. It is possible this is the same person.

At the time of the 1910 census in Pike County, Arkansas, Andy J. Alford, born about 1843 in Arkansas, is living with William A. and Sarah Alford. William A. was born about 1882 in Arkansas. This is probably the W. A. Alford listed in the 1880 family, with the father Andrew now living with him.

Can anyone help with this family?

Ultimate Ancestor James Alford

The following account was prepared by Gil Alford, who used a variety of sources and data submitted by several of the members. Jim Alford of Houston, TX, reviewed a copy of Gil's draft and most of his comments have been incorporated.

This James Alford was the progenitor of more Alfords than any other Alford ancestor known to date. Through two of his sons, Lodwick and Julius, he can claim more of our Association membership than all the other ancestors combined.

James Alford was born about 1687. probably in Virginia. Some believe he died in New Kent County, Virginia. between 1721 and 1735. More recent research in North Carolina suggests he moved there with the family and was the James Alford recorded in some of the earliest Alford history of that state. On this possibility Jim Alford of Houston added, "The older James in North Carolina may still have been the brother of Lodowick Sr. and not his father, though this is probably not the case since one or more of the brothers (James and Warren) staved in Virginia and continued producing Alford-Bailey descendants there."

There are two primary schools of thought as to his ancestry. One is that he is the descendant of a Benjamin and Mary (RICHARDS) Alford who was a merchant in Boston, Massachusetts. They did have a son named James who was born 19 July1691 and baptized 26 July 1691. Hugh Edwin Alford, in his IN SEARCH OF MY ALFORD ANCES-TORS, reported that his extensive research could not prove a connection with this family, and in fact, nearly proves the impossibility of such a connection. Contrary to some popular belief, there is nothing to connect this Benjamin Alford with Benedict and Alexander Alvord/Alford who came to

Boston from England in the early 1630's. The following are comments from Jim Alford of Houston, "As for James being from Boston, balderdash! Those people were city-bred merchants and artisans who looked down on the southern farmers and had nothing to do with them beyond visiting in trade ships. Why would the son of a Yankee trader with a London family move to a squalid tobacco plantation in Virginia? Did William and John move with him or did he just randomly settle with some distant cousins? Later, when the Boston crowd picked a fight with the Crown, they couldn't be nice enough to their country cousins."

Others believe that James was the son of a John or William Alford. Both were active in Virginia in the generation prior to James. Either or both of these candidate fathers may have come directly to Virginia from England. Circumstantial evidence seems to favor William as the possible father. The following comes from a paper done by Dr. John Abright Alford in 1981.

WILLIAM ALFORD in 1682 received a Land Grant of 450 acres on the south side of the York River in New Kent County, Virginia. A similar grant of 150 acres was made to JOHN AL-FORD that same year. Unfortunately, no information is available as to their relationship to each other. An easy assumption would be that they were brothers who came to America together.

Sufficient evidence is available, however, to be reasonably sure they were the forebears of many of the Alfords in the southern part of the United States today. It is believed they migrated directly from England, but they may have been descendants of Richard Alford who came over with the Roger Smith Expedition. The Vestry Records (1684-1786) and the Parish Registry (1680-1787) of St. Peter's Parish have many interesting references to Alfords during that time. Out of these records and others comes the claim that JAMES ALFORD was the son of either John or William, probably William, and this provides the beginning of the lineage of Barnabas Seaborn Alford" [John Abright Alford's ancestor].

Development of this conclusion illustrates how a mixture of facts, logic and assumptions are used to arrive at a conclusion. It is as simple as A, B, C, D:

- (A) As indicated above, William Alford's Land Grant was along the south side of the York River. A prominent route of the time, the "Upper Road", ran along this river.
- (B) The records show that James was the father of five sons: Lodowick, Goodrich, James, Jr., Warren and Julius.
- (C) The Vestry Book states that 'brothers Lodowick, Goodrich, Julius and James were required to tithe along the Upper Road in 1725'
- (D) It then is logical to assume that WILLIAM ALFORD WAS THE FATHER OF JAMES WHOSE SONS were required to tithe along the Upper Road.

The next two paragraphs and the subparagraphs, dealing with the ancestry of James, come from Jim Alford of Houston.

I've toyed with it many times and I'm still considering several most likely scenarios for the Virginia bunch:

- a. The simplest scenario is that "John Sr and William (of New Kent Co.) were brothers." This has been endorsed before. There are problems with it though, due to the apparent difference in wealth and probably age of the two.
- b. "John Sr. was the father of William, James and John Jr", ie., William and James were brothers, not father and son. This would fit your thinking, I believe and is a perfectly plausible supposition.
- c. "John Sr. was the father of William and John Jr., and James was a son of William." This may well be the ultimate truth. John Sr. was likely the brother of William (of Elizabeth City) who was in the King's service. They seem to have been age and wealth peers. John Sr. had money and transported plenty of indentured servants to help establish the Colony in the New World. William, the officer, was power-crazy and ultimately lost his life because of it.

Try this chart: John Sr. (ca 1640-1710), his brother Maj. William (ca 1642-1675)

William (ca 1665-), his brother John Jr. (ca 1675-1726)

James (ca 1690-1769), brothers unknown

(Circumstantial evidence suggests that William married a Tanner and James married a Bailey or vice-versa.)

A lot of the above is based on several observations:

- a. John Sr. was well-to-do and able to pay the transport of many persons, something that a young man without inheritance could not do.
- b. Wil'.am, the Deputy Escheator and militia officer, was a contemporary of John Sr. A 1671 deed of his was

- witnessed by a James who was likely a grown son. This might be the origin of the Colonial Dames assertion that James is descended from William and Dorothy of Elizabeth City. This should be noted in your article because it may well be correct! If so, it would make James a lot older than we believe now and mess up theories about him being in North Carolina later. I'm not ashamed to crawfish when I'm proved wrong!
- It is statistically improbable that с. all of the scattered John and William references around Virginia in the mid-to-late 1600's represented more than one or, at best, two persons of the same name. There were precious few people in Virginia (5000 or less) to begin with and the probability of there being more than a tiny handful of Alfords is very small. Within the general English population less than one in 20,000 (estimate) were Alfords, so why would we accept a different ratio in the Colonies?
- d. The scattered couples John and Elizabeth (1662), John and Lettice (1689) and John and Grace (1717) could well have been John Sr. and John Jr. My thought is that John Sr. was the one married to Elizabeth and then to Lettice.
- e. Due to the repeated use of names on the surviving lists of transported persons, we can't rely on that source to distinguish people or even discern the true data of their arrival,

We have nothing to prove or refute any of these theories about the father of James at this writing; therefore we presently consider James as the beginning ancestor (first generation) for many branches of our Alford line.

We know nothing of the wife of James

Alford. We do know that his children include at least the following:

- Goodrich Alford, born about 1708 in New Kent County, Virginia; died about 1753 in Edgecombe County, North Carolina; married Sarah _____;
- ii. Lodwick Alford, born about 1710 in New Kent County, Virginia; probably died Franklin County, North Carolina about 1800; married (1) Elizabeth _____ (2) Susannah _____ and probably (3)
- iii. James Alford, born 7 February 1712/13 in New Kent County, Virginia and baptized there 12 April 1713 in St. Peter's Parish.

iv. Warren Alford, born about 1715 in New Kent County, Virginia, and baptized there 28 August 1715 in St. Peter's Parish; may have died young;

 v. Julius Alford, born September 1717 in New Kent County, Virginia, where his birth, but no baptism, was registered in St. Peter's Parish; died 1771 in Bute (later Warren) County, North Carolina; married Lucy ?NEW-TON?.

Jim Alford of Houston added, "James very likely had another son, John, who went to North Carolina. He appeared in the 1749-52 Granville County Tax Lists living near Julius Alford and John Ferrell. Until I actually examined the tax lists (thanks to Bill Mitchiner and James Sorrell) I was inclined to dismiss him as a 'stray.' He had only one tithe. may or may not have had children, and likely died in 1752-53. This would bring the known sons to six: Goodrich, James, Lodowick, Warren, Julius, and John and would be consistent with known family naming patterns (no Richards, Anthonys or Thomases in the group!)."

Part 2: The Descendants of Alexander Alvord

From A Genealogy of the Descendants of ALEXANDER ALVORD an Early Settler of Windsor, Conn, and Northampton, Mass, compiled by Samuel Morgan Alvord (Webster, NY: 1908)

English Alfords

ORIGIN AND EARLY MENTION OF THE NAME ALFORD IN ENGLISH RECORDS. THE RELATION OF THE AMERICAN ALVORD FAM-ILY TO THE ENGLISH ALFORDS.

In any consideration of the earliest data regarding the Alvord family, it must be remembered that the name is identical with Alford* and that all the Alvord family ancestors in England were ALFORDS and not ALVORDS. There are a very few instances of the latter spelling in Co. Somerset, Eng. The transition to Alvord from Alford was a natural one since f and v are kindred letters. (The descendants of Alexander Alford, the progenitor of the American Alvord family have consistently spelled their name A-l-v-o-r-d. The descendants of the other Alford immigrants have used the original spelling). It therefore follows that in observing the early occurrences of the name in English archives and records, it is more important to note similarity to Alford than Alvord. Hence, there is little reason to believe that there is a reference to the Alford name in the Domesday Book of William the Conqueror (1060), although one Alward and one Allured appear, each possessed of a hyde of land (about 100 acres).

* The following variations of spelling the name occur in the early New England records: Alford, Allford, Alfred, Alvard, Alvart, Alverd, Alvert, Alved, Allord, Alloord, Alluard, Alluerd, Alhurd, Olford, Olverd, Olvord. It has been suggested that the name was originally Alfred, from King Alfred the Great, but evidence is lacking to support such a theory. Nor should it for a moment be thought that the name is derived from a place where "all forded" the river. The name is distinctly Saxon in origin rather than Norman and the true source or derivation of the name is furnished by Canon J. G. Alford of Bristol, England [author of the other 1908 book being printed in this quarterly].

"Alde was an ancient form of old as in alderman. Aldeford was the old ford across a river, and Robertus Dominus de Aldford was master, lord or governor of a military station (Aldford Castle) commanding the old ford across the Dee above Chester. The changes then followed: Richard Dom. de Aldford Radulf de Aldford Henry de Aldford Robert de Alford (a descendant of "Bigot" who came over with William the Conqueror. He was miles [Knight] in 1160). Thomas Alford Alexander Alvord. (The above is not to be taken as a direct line of ancestry.)

"This comes from the oldest pedigree of the name, and the connection of the Somerset family with the Aldford Castle in Cheshire is early but distinct. The northern Alfords gradually died out or sank in position, while the Somerset Alfords became land-owners (though not extensive ones) about 1560, and have maintained their position as professional gentlefolk."

The following are very early occurrences of the name:

"Middleton or Milton (Clivedon), Fol. 48, No. 114. Grant by William de Clyveden for the good of his soul and those of his parents and friends to the canons of Bruton of the church of Middleton. Testibus: Roberto, Archidiacons Ilberto et Servasio decanis, Rogero de Alderforda, etc.

"Folio 14,15. No. 35, A. D. 1256. Agreement made in the Lady Chapel of Bruton between Sir William, Prior of Bruton, and William de Careville before Sir H. Lovell. Sir Ralph sine Averio (Sansaver) Hugh his son Knights, Master Thomas de Alde the ford (Alford) John Rufus of Lamay, etc. Richard Landres, William Pincema Mathew de Betevile, etc. The said William de Careville released to the prior all right which he had in the pathes and foot stiles above the Barn of the said Prior in the field which is called Hyde toward Begwode. Testibus:

Wittelmo de Plescey, Wittelmo Hurcarl, Robert de Crudenhulle, W. de La Lade, Henrico de Campoflorido, Wittelmo de la Coume, Thomas de Dike.

"No. 202. Deed by which Isabella who was the wife of William Fitz Adam of Cherleton, etc. (quit-claim), this is a very long charter.) His testibus: Domino Andria Wake, Domino M. de Doneheved, Domino Humfrido le Kael, Domino W. de Loueny Majisto, W. Fauerole, R, Bissop, W. de Combe, Radulfo Huscarl." (Somerset Rec. Soc. Vol. 8.)

In 1292, 20 Edward I, certain lands at Barrington and Chillington, Co. Somerset, were held "by the service of finding a man on foot to serve at the Castle of Aldford, Cheshire, in the time

of war." (Canon J. G. Alford.)

In 1327-8, Edward I, the names of Thomas Alford and John Alford appear under the parish of Henstridge, Co. Somerset. (Subsidy Rolls.)

In 1335-6,9 Edward III, John Alford of Williton, Co. Somerset, cler, made a grant of a tenement at Williton. (Hist. M. S. Com., Vol. XVI, p. 74.)

In 1484 there died an Allford, Vicar of Cannington, near Bridgewater. "There was an inscription in Brass under the Alter steps" to his memory, in which he was called "a Benefactor." (Collinson's Somerset.)

In 1520, Thomas Alford, patron of Pilton; in 1523, Henri Alford and George Alford, both of the Hundred of Whitely; in 1524-5, John Alforde of Ile Abbotts and John Alford of Bickenhall, all in the County of Somerset, are mentioned.

The foregoing is sufficient to show the antiquity of the family and that it was early established in Co. Somerset, which will be shown to be the locality from which the progenitors of the Alvord and Alford families in America came, i. e., the descendants of Alexander and Benedict Alford. No evidence exists which shows whether any of these early names are in direct line of the American families.

"The Alfords of Somerset were landowner in the county, as is still the case, and two members of the family were county magistrates—the family being one of evidently good position in the county for the last three hundred years—but they became known chiefly as a clerical family. A veritable family of priesthood, six successive generations, in two diverging but unbroken lines, having taken Holy Orders." (Canon J. G. Alford.)

Henry Alford, D. D., late Dean of Canterbury was a descendant of the Somerset Alfords.

The Family Registry

I spent a few days in at the Family History Library in Salt Lake City in August, gorging myself on genealogical research. Whenever I hit a dead end or couldn't make my brain think anymore. I did something easygrabbed books from the Georgia shelves (where my Alfords were) and copied every indexed page with an Alford on it for the Booklist, At five cents a page, copies were a bargain! On Sunday, when the library is closed, I typed 'em up on my trusty Mac-that's why all the books listed in this quarter's "Booklist Additions" are from Georgia!

Unfortunately, I didn't make any progress on my own line of Alfords, but I had a good time, and I found out about a new service the library offers that I think AAFA members should know about: The Family Registry. According to their brochure, "The Family Registry can help you find others who are doing research on the same family lines you are working on. You can then contact them to coordinate your efforts and share results."

Basically, you submit a Research Coordination Registration form for each individual you want to register to the library. They then computerize the information and include your name and address as the researcher.

Then, like I did, other researchers can look up the names they are researching in the library's computers. If you look up John Alford, for instance, all the entries with that name, including all the spelling variations, will pop up, along with some identifying information: dates, places, spouses, and/or children. Hit a couple more keys and the name and address of the entry's submitter is displayed. I found several people researching some of my lines, and one had a lot of data I didn't have! Now I'll write to them and share info. Even if these people have moved or don't answer my letters, I printed out the information (five cents a sheet again) and now have a lot of leads on new lines!

However, when I actually looked up Alford, I was surprised to find that about 90% of the names were from New England or England. Only a couple of southern lines were represented. Turner Alford from Georgia and his family were being researched by someone, and several entries that had the Seaborn name in them were displayed. Other than that—zip for Southerners!

I felt so bad about this that I decided to make it easy for all AAFA members to register their Alford (or any other) families in The Family Registry. I've enclosed a blank form which you can fill out and submit on one of your Alfords—but they must be deceased. (If you're a northern Alford, do it anyway because all researchers on an individual get their names listed.)

Try submitting the name of one of your problem people, as long as you have at least one identifying date and/or place. If you get really ambitious, xerox the form and submit lots of them! The more exposure you get, the more results you're likely to receive.

And if anyone writes to you and you can't help them or you don't really connect, send their letter to Gil at the Association address. Maybe AAFA records can help, and maybe we'll get a new member!

This is a great deal—it's free!—so don't pass it up!

The Lost Graves

Summer, 1854 Troup Community, East Texas

Spire W. Alford paused for a moment to wipe the sweat out of his face. He was chopping the weeds out of 40 acres of waist high corn. The woods past the field were full of game, including deer, rabbit, and squirrel. This was a good place. Resting with one arm wrapped loosely around his hoe, Spire bent down and scooped up a handful of soil. It was sandy, but well drained and suitable for growing a crop for the farm animals.

For four long years, Spire had worked to build a house, clear the land, and put in a crop. Soon, he wanted to have his whole family together again. His wife Caroline made only infrequent trips to visit. She was so far away and he missed her.

Spire was worried. He squinted in the hot, July sun and glanced over his shoulder in the direction of the house. A slave named Dorcas was there looking after two of his children: 16year-old Marcilius and 14-year-old Partha. They were sick with the fever. Spire was weak from the fever too, but someone had to work the field.

Spire was a long way from LaGrange, Georgia. There waiting were Caroline and four more children: Leonidas, Didema, Alexander, and Spire Jr. Back in the spring of 1854, a pregnant Caroline made the trip to Texas to visit her husband. Despite the distance between them, they managed to get together every several months or so. On the way back to Georgia, she delivered a baby boy. She named the boy Spire Warren, after his father.

For several generations, settlers had worked the land there in West Georgia until the soil, drained from years of cultivation, began to produce less with every new year. When the land gave out, people moved West to fresh areas which had never before seen a plow. Spire, like so many of his contemporaries, looked to the West to find his future. Spire and a cousin named Sippy Alford first traveled to East Texas around 1849. The war with Mexico had been won and the great Republic of Texas had been admitted to the Union as its largest state in 1845. New settlers were welcomed with open arms. Spire bought 1260 acres of land in February of 1850.

By the summer of 1854, Spire was one of hundreds of pioneers who populated the fertile Red River valley area just about 30 miles southwest of Texarkana. Back in Georgia, Caroline Cotten Alford waited for her husband to send for her and the other three children. But by August, 40-year-old Spire and his two oldest children lay dead from the fever. Spire left behind a fully furnished house, a female slave, several hundred acres of land with 40 acres of which in a high state of cultivation, numerous farm animals, and farming implements. In short, an estate worth thousands of dollars-which in 1854 was considered a small fortune. Spire never got to see his youngest son.

Claim against the Estate of Spire W. Alford

Made July 15th, 1855 (Note: The third child mentioned below is speculated to be a daughter of the slave Dorcas named Harriott. Dorcas and Harriott are listed in the inventory of the estate as property of Spire. Dorcas is listed as being worth \$350.00; Harriott is listed as having no net worth, probably because of her youth, and the fact she is female).

For John L. Dennas

To building rock wall around the grave of the deceased and three children, \$15.00

Personally appeared before me James

Brown and acting Justice of the Peace after being duly Sworn deposith and Saith the above account is just and true to the best of his knowledge after all just credits are allowed.

Sworn to and Subscribed before me this 12 of July 1856, J. L. Dennas

Santown, Georgia June 28, 1856

I herby autherrise you as the administrater on my husband's Spier W. Alford's esstate to sell all of the lands that he owened in the State of Texas at the time of his death and I herby wave my right as his widder to take my dower on the lands that he died in persession of in texas and I herby autherrise you to sell and make a feesimple title to my intrestes in said lands and I will come in as a child for my introust in said lands in witness wherof I herby signe my hand and seal this the 28 of June 1856.

The following is the text of a personal letter included with the one above. The one above is more of a legal document.

We are as well as common we have

nothing knew. The people are generally well cropes are only tolerable. The season has bin dry. We need rain at this time what cropes was injured with the rust. I wount you to reserve graves and the grave yarde in some of the lands I dont wont the land cleared upe to the graves. If what I have said in refferance to the land is insurfishent. I am willing to do anything that is nesserey after the land is sold I can sign the deed to the percheraser if you thinke it is nesserry let it be knowen on the day of the sale that the title be good....give my love to cousin Elizer & the children I should be glad to see her. Say to Dorcas that I wont her here verry mouch. I hope that next winter we all will get to gether again. I moust close. Yours in Last,

The State of Texas County of Cass Late August, 1854

The condition of the above obligation is such that whereas the above bound has been appointed administrator of the estate of Spire Alford, deceased. Now if the said Sippi Alford shall well and truly perform all the duties required of him under said appointment, then this obligation shall be null and void, otherwise to remain in full force and effect.

Cousin Sippi I availe my self of this opitunity to drope you a few lines you will lerne that we are all well. I was glad to here by Wm Leftwick that you & yours wer well. I have bin expecting a letter from you for some time & when Wm Leftwick came in I was in hopes that you had sint me some word about my businefs but he sayes that you sint me not a word. I was in hopes that you would have the esstate wound upe this winter so that I could have got what little was coming to me this winter but from what William Leftwick sayes I fere that I shant be able to do so. I was making arrangements to come or send to Texas this winter to have a settle ment with you on the esstate but from what Wm Leftwick saves I think it best to wait

owntell I can here from you. He sayes that he dont thinke that the man that bought the land will be able to pay all the money this winter & if he dos not you will not be able to make a final settlement this winter. I wish you had sint me some money by William. I think if you knew how mouch I need money you would have sint me some. I have now bin here three years without a dollar & at the mussey of my friends for the two last years I have wonted to buy me a home but I could not for the wont of money, J.A. Palmer has bought Andrew Alford place and is willing that I should live ther but I have no money to buy such things as I need to go to house keeping so I dont know what to do. When you get this I wont you to thinke of my condition & do the best you can for me. If you can wind up the esstate this winter I wont you to do so & if you can & will let me know I will make some arrangements to have an agent ther to make the settlements with you & bring what little ther is to me. If you cant wind upe the esstate this winter & be ready for a final settlement it is not nesarsary for me to come or sind as I wont one tripe to do. If you cant wind up the esstate this winter I wont you to send me all the money that you can if you can see any man coming from ther to Georgia that you can depend on. I know a man who expects to go to Texas some time soon if you will write to me that you have money that you will send I will get him to call & get it. Wm Leftwick sayes that Jarrel Hogg will come to Georgia soon. If he dos you could sind it by him if you have any money that you can sind. You need not be affraid to sind it. I will give you any showing that you wont. I wont you to be safe & I will do any thing that will make you safe. I have letters of Gardianship for the children & can give you a proper receit. Send the money by a responable man & whin he gives me the money I can give him a receit or I can sind you the receit or I will give it to any man that you will name & he can hold the receit or sind it to you. Cousin Sip money I need &

money I must have if I can possibly get it. If Jarrel Hogg dos come to Georgia I wont you to sind Dorcas by a responsible man that you see that is coming to Georgia & I will give you a proper receit for her. Be sure to write to me as soon as you get this. If I can get any money I wont to know it & if I cant get non I wont to know. So be sure to write so I will know what to depend on if I am to stay her & beg my bread I won to be at it. Wm Leftwick telles me that you have a man ther for me. If I have to get married I will, so send me the money or the man. I am on the carpet. Widders have a hard time in this world so I moust marry if I can. Cousin Elizer I often thinke of you. You may have some day of my troubles since I left you but you dont know what they have bin. You moust pray for me. You may be a widder some time. Except my love for you & all your family.

Buy one on the Continental Bank of N.Y. if you can & if you cant get on that Bank. Why any good Bank of N.Y. will do. Have the check made parerable to J.A. Palmer & send it to him to Longcane Post Office by male. Be sure wen you buy the check & mail it that you can prove that you did buy one & make it to J.A. Palmer if it ever shouled be nesersary. Attend to this as soon as you can if you pleas. I will send you the receit for the money in this letter.

From the tenner of your last letter you appered to be a littell netteled at my last letter. You put a rong construction on my letter. I never have bine affraid that you would intenchonly cheat me out of a dollar. I have ever esstemed you as one of my best friends & I will never forget your kindness to me when I was in Texas. But I did fere there was some misstake & that was the reason that I wonted you to send me the different amounts & the expences of

the administration & I thinke a littell harde of you for your ansur of that parte of my letter. If you was to aske souche a favor of me I certinly would take a plesure in accomerdating you and I think you ought to give me all the information you could as I am a pore widder & have no one to go to Texas & looke after my introust. I know it would have put you to some trouble but I hope you will be paid for all of your trouble with me. From your letter the land brought \$1700 or \$1800 houndred dollars & the perisherable property brought over eleven houndred dollars & the Dennis & Wilerame Det if I remember right was some twelve houndred dollars & Dorcas hiered for some fore houndred dollars that makes some \$4500 dollars & I dont thinke that A. Alford was in det mouch you lost but in det of \$124 that I ever herd of & you have sente me \$2164 & have but nine houndred more making some three throughsan dollars that I get has the expences bin \$1500 dollars and some of the money ought to have bin on introust & the land was rentied for somthing. It dos looke to me like there was some mistake.

I entend to have the thing looked into some day I thinke it is my duty to do so. I have my children to rase. My husband worke hard for what littel he had & his children ought to have it. I know you wont them to have all that is coming to them & would not cheat them out of a cent. But you are like other men lierable to mistakes & have made some. You wrote by Mr. Trammel there would be but abought one hundred dollars more & I see there is at least \$939.70 more if you make one mistake you may make more. I hope you wont think hard of me for this plane talke that is the way for friends to talk. The old adage is a good one watch your friend & you will have no enermies. I wish I could se you and talke this thing over but hope you understand me. My Self & family are as well as common. We are trying to do the best that we can. We have nothing new or strange except the Female

Collage in Lagrange buned down last Wensday night. We have a late cold spring. Give my love to Cousin Elizer & the children & Palmor & his wife & children & Low & his family. I dont know that I ever will see you all any more in this life but I shall remember you all as long as I live for your kindnes to me. You moust continue to write me. Tell Cousin Elizer to write to me.

Administrator shows by the account current that said estate is in his debt three thousand and three dollars and that he has received three thousand. nine hundred and forty two dollars and seventy cents leaving in his hands belonging to said estate the sum of nine hundred and thirty nine dollars and seventy cents and prays for the court to pass an order authorizing this administrator to pay said last named sum of money to Caroline M. Alford, surviving widow of the deceased, in her own right and as guardian for her children and take her receipt for the same and be discharged thereafter from further liability and will forever pray,

Civil War Era 1861 - 1865

Caroline M. Alford marries Thomas Winston Slaughter. They move across the state line to near Roanoke, Alabama in Randolph County.

March 29, 1864 West Point, Georgia

Fifteen-year-old Alexander Alford enters the service of the Confederate States at West Point, Georgia. He serves in Company D of the 37th District Georgia Militia. Serving under Colonel W.W. Cato, he advances in rank from private to order sergeant. One of his responsibilities is to guard the bridge spanning the Chattahoochee River along the Alabama/Georgia border. Alexander is furloughed March 1, 1865. Almost 50 years later, Alexander is denied a pension because he served in the Georgia Home Guard, not the regular infantry.

Troup County, Georgia November 1, 1874

Alexander Marshall Alford, Spire's next to youngest son, marries Frances Elizabeth Shank.

Winston County, Alabama Summer, 1879

Alexander and his family move from Troup County, Georgia to Winston County, Alabama near what is now the Bankhead Wilderness Area.

Cornett Community (previously known as Troup Community) 1929

The Cornett family discovers a rock wall on the land previously owned by Spire Alford. The wall encloses an area measuring approximately 12 feet by 12 feet. Most of the rocks are removed to the Cornett house some distance away for the construction of a "summer cellar." What remains of the gravesite is a low rock perimeter about a foot high which is soon hidden by the growth of underbrush.

Morris County, Texas Summer 1954 (100 years after Spire's death)

A light blue Buick Roadmaster pulls up at a small service station in Daingerfield. Out step Marshall and Owen Alford, great-grandsons of Spire Alford. They had always heard of the legend of Spire who died in Texas a long time ago. They know the graves are marked, not with headstones, but with a rock wall. The purpose of the stop is to find someone who knows where the graves are. The service station attendant has never heard of the graves and does not know any Alfords. Marshall and Owen try a couple more places in town, but eventually drive back to Winston County, Alabama somewhat disappointed. Over the next several years. Marshall and Owen occasionally stop in Daingerfield and ask about the graves.


Linden, Texas Cass County 1986

Spire W. Alford's estate papers are discovered in the Court House in Linden. Copies of the estate papers, and copies of correspondence between Caroline and Sippy Alford belonging to Della Mae Kennedy are forwarded to Alfords living in North Alabama. Descendants of Spire and Sippy Alford exchange letters and phone calls.

Morris County, Texas March 1987 (132 years after Spire's death)

Marshall and Owen Alford, each accompanied by one grandson, meet Jim and Linda Alford and their children

including honeysuckle vines, blackberry bushes, and sage brush.

The search party covers a few acres near the Cornett houseplace, but to no avail. At one point in the search, Marshall holds up a 50 dollar bill and offers to give to it the first one to locate the gravesite. By now, it is late in the afternoon and the search party is growing tired and hungry. The search is called off about 4 pm. The next day, the Marshall and Owen Alford group travel back to Alabama. Before they leave, Jim and Linda assure them the search for the gravesite will continue.

Roanoke, Alabama Randolph County 1988


Owen Alford and his oldest grandson, Mitchell Owens, travel to Bethel Church just South of Roanoke to the gravesite of Caroline M. Alford Slaughter. They replace Caroline's headstone which, over the years, had weathered and was broken.

Summer, 1990

Marshall and Owen are getting older, but often think of going back to Texas to visit, at least once, their greatgrandfather's gravesite. The grave is still lost, but the scarch has not been discontinued. Perhaps someday soon, the gravesite will be discovered. It is not known

outside the post office of Naples, Texas. Jim Alford is a direct descendant of Sippy Alford. It is the first time in over 100 years descendants of Spire and Sippy have gotten together. From the post office, two vehicles drive to the Cornett Community in Cass County. At the Cornett house, the summer cellar constructed of the rocks from Spire's grave is found.

The group is joined by David Thomas who grew up in the area and has seen the gravesite. But he doesn't remember exactly where it is. Marshall and Owen are both in their eighties, but effectively lead the party of 10 or so searching for the gravesite. τ .e soil is sandy and most of the area is covered with 10 to 15 year old pines trees and various low growth

for sure if the site still exists, even though various area residents claim to have seen it over the years. It may have been covered by undergrowth; the remainder of the stones may have been inadvertently removed by some wellmeaning neighbor; or the site could have been bulldozed for a county road or some other civic project. The hope is, the site can be found and Spire's final resting place can be properly marked. Then he can be recognized and remembered as the East Texas pioneer that he was.

Ghost Stories

Maybe it's only coincidence mixed with wishful thinking—not the stuff of genealogical research, certainly—but doesn't it sometimes seem that the spirits of your ancestors are nudging you in the right direction? AAFA has two members who've experienced the ghostly nudge, and they were impressed enough to share their stories with us.

Looking for Answers in All the Right Places

My missing grandfather has been found, or at least the trail has been picked up after 87 years! This IS a ghost story.... I went to San Francisco last summer looking for Grandfather. All I found were two dead sisters and a brother. Not being one to miss an opportunity and having had a few beers, I went to the cemetery on my last night there and "asked" his sisters where Grandfather went. (I ruled out asking his brother since he had been cremated.) Less than one hour later on PBS, I watched the "answer"-a special on the building of the Panama Canal! I knew this was it, and I kept studying the photos looking for ole Grandfather! Seven months later, I

found where to write for information on people who built the Canal....YES, dear readers, Grandfather went to work on the Canal, February 17, 1906, after hiding out three years in New Orleans. The National Records Center, St. Louis, sent me copies of his employment application papers.

Out in the Trenches

This one's anonymous . . . so we won't think he's crazy!

In 1984 or '85 my wife and I visited the Vicksburg battlefield in Mississippi. As we entered the drive behind the Confederate lines at the northern perimeter, I had an indescribable feeling so strong that I stopped the car and walked along the trench lines and just stood there, soaking it in. Now the strange part. I recently learned that my great-grandfather served with Company C in the 27th Louisiana Infantry and had fought and been captured at Vicksburg. A map of the Vicksburg defenses shows the 27th Infantry was dug in on the northern perimeter for the entire battle! I was probably standing within 100 yards of their trench when this occurred, but that was before I even knew my great-grandfather's first name!

Part Eight: Josiah Alford's Alford Family Notes

London and Hertfordshire

We now remine to the family of Sir Edward Alford.

6. John Alford of Hamsey and Offington, co. Sussex, esquire, was the son of Sir Edward Alford by his second marriage with Ann Corbett. He was born about 1645. The Alumni Oxonieneses, Equitis gives the following:-"Alford, John, fil. Edward of Offington, Equitis. Church of Christ. Matric: 1664, age 17, of Offington." He lost his father when only eight years old, and succeeded to the Sussex estates on reaching the age of 21. He married the following year, and had nine children, of whom four died in infancy and two others at later ages, as shown in the pedigree, Table III. The three who survived were:

- Mary, born in 1669, who, in 1697, married Colonel Sir Thomas Wenham.
- Elizabeth, born in 1671, who married Richard Bridger, of Hamsey Place near Lewes.
- iii. John, of whom next (7). In 1679 at the age of 34. John obtained a seat in Parliament, sitting as representative for Midhurst, Sussex, from 1679 to 1681, and for Bramber from 1688 to 1689. He died at Offington and was buried at Broadwater, in 1691, at the age of 44. His widow, Sarah Alford, lived till 1737, when she died at the age of 86. Her monumental inscription, upon a flat stone in the church at Broadwater, is:

In memory of John Alford, Esquire, who died May 16, 1691, at aged 44. Here also are deposited the remains of Mrs. Sarah Alford W'.o lived his wife 23 years, and his widow 46. She departed this life Jan. 22nd. in the 86th year of her age, and our Blessed Lord 1737."

Also at Broadwater, are the following inscriptions to their children:

"Edward Alford, Esquire, son of John Alford, Esquire, of Offington; ob: January 18, 1697; act : 17."

"Mrs. Sarah Alford, daughter of John Alford, Esquire, late of Offington. Died Feb: 3, 1727. Aged 50."

7. John Alford, of Coombe, co. Sussex, Esq., was the youngest and only surviving son of John Alford of Offington and Sarah his wife. He was born in 1683, and matriculated at New College, Oxford, in 1701, being described as "Son of John Alford of Offington, Armiger. Desiring to follow in the steps of his father, grand-father, and great-grand-father, he endeavoured to enter Parliament, but apparently failed to obtain a scat. There is no record of his marriage, and in 1744, at the age of 61, he died leaving neither widow or child. In Broadwater Church is a mural monument in the north transept: "To the memory of John Alford, esquire, who died 1744, the last of the ancient family of that name heretofore of Offington in this Parish; whose remains, together with those of his ancestors and kindred, lie buried in this channel." The direct line of the Sussex Alfords thus came to an end, as his monumental inscription records, and the Sussex property passed away from the family. "The manor of Hamsey (Coombe Place), near Lewes, was devised by John Alford, esq., to John Wenham," son of his sister Mary. who married Sir Thomas Wenham, Some part of the property also passed to the Bridgers.

The following may here be noted: Major John Alford is mentioned several times in the year 1645. His connections

with Berkhampstead, in Hertfordshire, would lead one to suppose that he belonged to this second, or Sussex. branch of the family. While he was noted as a Parliamentary soldier, Sir Edward as we have seen, was severely fined as a Royalist. "Wednesday, September 10, 1645. At two o'clock this morning the signal was given to storm the City. The horse were commanded by Major Alford, and within the line met a party of the Royal Horse. whom they forced to retreat, mortally wounding Colonel Taylor, and taking several prisoners." Evans' History of Bristol, pp. 203, 204.

"In 1650 Major John Alford held Crown lands on an unexpired lease at Berkhampstead." Clutterbuck's County of Hertford.

"Major John Alford, a Parliamentary Soldier, held Berkhampstead Place, Herts, under lease in 1656. Berkhampstead House, Manor, or Castle was leased by King James to the family of Morays, or Murrys. The Great Park had contained 1252 acres. About the time of King Charles the Murrays left, and the unexpired term of nine years was assigned to Major John Alford in February, 1650. The Estate and Manor of Berkhampstead are now held by Lord Brownlow under the Duchy of Cornwall." Public Record Office Papers.

The Cornwall Library at Naseby contains a small quarto illustrated tract, not found in the British Museum, published in London 1651, entitled A Narration of the Proceedings of this present Parliament and their Armies, etc. Page 19 begins: "A full narrative of the late dangerous designe against the State, written with Master Love's owne hand, whereby he setteth downe the several meetings and secret actings with Major Alford, Colonel Barton and others."

An Essex connection of the family is apparent, for the will of Roger Alford of Chelmsford, 1517, shows that the family were then of some position in the county. A writ to the Sheriff of Essex, 7th Elizabeth, 1565, mentions John Alford of Southweld: also Stephen and Thomas Alford of Felstead. In the Visitation of Essex in 1612 we find: Arms (quartered with Raynsford) Gules, a cross flory argent, Alford. And elsewhere the record of the marriage of an Alford with Robert Kempe of Finchingfield. In 1662 Theophilus Alford, son of John Alford of Ashton, Devonshire, became vicar of South Weald, and his son, John Alford, described as of Brentwood, Essex, matriculated at Trinity College, Oxford, in 1675, aged 16. Edward Alford, son of Roger Alford, was M.P. 1603 to 1628 for Colchester. The records of Monoux Foundation School at Walthamstow, in Essex, giving some interesting particulars concerning the Alford family. "Robert Alford, (the father of Roger) was one of the original devisees in Sir George Monoux's Will." The Governorship and Trusteeship of the Grammar School which he founded at Walthamstow thus coming into the hands of the Alfords. In 1599 "Edward Alford, grandson of the devisee, and son of Roger, being in possession of the premises in conjunction with Elizabeth Alford, widow (of Roger) and Edmund Fettiplace (their son-in law) became himself a Benefactor to the Charity." His benefaction being still known as "Alford's Gift." The Alford property on which the charges for this Charity were made was in the parish of All Hallows Staining, in London. It was reported formally in 1636 "that Schoolmasters had been appointed by the Alfords who had been unable to teach the Latin tongue." An "inquisition" was held and a new "decree" made by a Commissioner in 1658. We may here record the following entries in the Registers of St. Dunctan's in West, London: 1589, Feb. 10, Elizabeth, daughter of Edward Alford, gentleman, baptized. 1592, Jan.

7, Anne, daughter of Cuthbert Alforde, baptized. 1601, June 14, Robert, son of Edward Alford, gentleman, baptized.

The Alfords of Hereford, London, and Clarendon Park

The exact descent of this family is not clear, but it apparently formed the third branch of the Northern stock. The founder of this branch was Thomas Alford, presumably the youngest son of Thomas and Jane Alford, of Holt (see table). Of him we have these particulars: The Public Record Office Ancient Deeds, Hereford, B. 530, mentioned a "Bond by Walter Waters, rector of Bishopstone, co. Hereford, and Thomas Alfford, of Brownshyell, in the said county, 20 Henry VII, "Thomas Alford was appointed "Gentleman Usher of the King's Chamber" to Henry VIII.

The British Museum Royal MSS. contain the following interesting record concerning him: "Clothes and Jewells delivered to Thomas Alford, 16 November, 20 Henry VII. A purple damask gowne with gold fringe, with 130 diamonds set in golden buttons, and 131 flowers of gold and pearls on the guarde gowne. A purple doublet with 54 rubies and gold buttons and



points," etc., etc. fhomas Alford was afterwards appointed "Spigurnel," or"Sealer and Signer in Chancery," in which capacity he is mentioned many times in Royal Office State Papers of the years 1533 and 1534. Vol. vi, 578 (25), May 1533, records a "Grant to Thomas Alford to be Keeper of the New Park, near Westminster, with the custody of the King's Lodges in the same Park; and Receiver of the Rents of the Lands near Charyng crosse lately acquired by the King from Abbot and Convent of Westminster."

Also vol. vii, 1601 (2), December 1534, "Grant in Fee to Thomas Alford of lands called Brookys at Ipswich, Suffolk; Westminster, Dec. 2nd "A circumstance of especial interest is that he was a witness to the "Sentence given concerning the validity of the King's Marriage to Anne Boleyn: present, Thomas Cromwell, Thomas Leigh, LL.D., and Thomas Alford." Vol. vi, 737 (2).

He died at a comparatively early age in 1535, for a "Grant" of that year mentions "Thomas Alford, deceased, Signer and Sealer in Chancerv," His son appears to have been 1 2 John Alford, of Cawther Hill, co. mereford. His will is to the following effect : John Alford of Cawtherhill, co. Hereford, 1614. To be buried in the Church of Norton. Bequest to the Church of Norton. "Elizabeth my wife. . .William my sonne. . .Alice my daughter. . . My sonne Thomas' daughters. . John Allford my sonne. John Alford sonne of my sonne John of Webley." "My best mare. . .my best horse . . . my good mare . . . my yearlinge colte." My son Richard. Elizabeth Meredith my son Richard's wife's daughter. My daughter Margaret's two sons John and James. Thomas son of my son Thomas. My son William, Executor." P.C.C. 91 Lawe.

John Alford married Elizabeth and had issue :

- i. William Alford (see Table IV)
- ii. Thomas Alford, of whom next (3)
- iii. John Alford (see Table iv)
- iv. Alice, m. Pritchard
- v. Margaret
- vi. Richard Alford of Norton Cannon, Hereford, whose will was proved in 1634: "To be buried at

Norton. . . Phillipp the son of William Alforde. . James, John. Margaret and Joyce, Children of the said Wm. Alforde. . . John Alford the vounger of Welles. . Joan the daughter of James and Catherine. . . Her sister Alice. . . Alice Pritchard my sister. . . To my brother William my house at Norton. . James his son. . . My sister in law Joyce Alforde. . . Margaret Alforde my sister in lawe. . . John Alforde and William my brothers. . .Marie Alforde. . . Margaret the younger. . .Joyce the younger. . .Mary Alforde. . .John Alford my brother, Wm.h is sonne. . . Philip Alford, James Alford, John my brother." P.C.C. 82 Scager.

3. Thomas Alford, of Coventry, gentleman, was the second son of John Alford and Elizabeth his wife. He died 1616, and his will is to the following effect: Thomas Alford of Coventrie, * 1616. "To my wife Alice my nowe dwelling house in Well Street in the citie of Coventrie, with the stable and gardens, also my house called the Croft in Bishopgate Street, and after her decease to my sonne John Alford, and for lack of issue to my sonne Thomas Alford (a minor). . . To my wife all my plate . . . My daughters Johanna, Anne, Mary, Sara, Hope, my five daughters . . . To my daughter in lawe Alice Hope a piece of plate." "If anny of my sonnes and daughters doe take riotous and ungodly courses, and will not be ruled by the counsel of their mother. that stubborn and disobedient child shall have no more than £20." P.C.C. 51 Cope

He married Alice Phelps, of Tewkesbury, whose will here follows: Alice Allford of Conventrie, widow, 1617. Bequest "to poore of Tewkesbury where I was borne. . .all of my lands at Tewkesbury to Alice Stawell my daughter," Edward Stawell her husband land in St. Giles in County of Cornwall. AAFA ACTION

"To my sonne John Allford. . .to Thomas Alford my sonne. . .to my five daughters." P.C.C. 51 Cope

Their children were:

- i. John Alford, of whom next (4), ii. Thomas Alford. He was educated at Emmanual College, Cambridge. "The Rev. Thomas Alford was Minister of Daventry 1635-1637. The Registers for the year ending Lady-Day 1635 were signed by his predecessor; those for the year ending Lady-Day 1636 by himself: and those for 1637 by his successor. His death does not appear in the Register of Burials probably therefore he resigned," He married Alice Hope, "There are no entries in the Register as to any member of his family."
- iii. Johanna, m. Edward Farmer.
- iv. Anna, m. Benjamin Wheate.
- v. Mary, m. Benjamin Farmer.
- vi. Sarah, m. John Needham.
- vii. Hope, whose inscription is at Drayton, in Leicestershire, as below: Arms: Gules, six pears. "Here lyeth the body of "Hope Alford, the youngest daughter of Thomas Alford, Esquire, who dyed 25 November 1636, anno aetat: suae 23."

4. John Alford, of London, mercer, entered his pedigree in Visitation of London, 1634. He is described as descended from the old Alford family at Cheshire, and the Hearlds confirmed to him the arme in the same year. He became a man of considerable wealth and importance, and lived in later life at Clarendon Park, Wiltshire, "an ancient palace and domain two miles south-east of Salisbury, once the seat of the Earl of Pembroke." "The manor belonged to the Crown, and was granted by Charles II to the Duke of Albermarle, from whom it passed to the Earl of Bath. The magnificent estate of Clarendon Park extends over 4,000 acres. There is an

excellent Manor House, with remarkably picturesque Park of 300 acres. which is richly timbered, and the lake in it is the noted resort of wild-fowl. Here the famous Constitutions of Clarendon were signed in the 12th century. Here also Edward III and his royal prisoners, the King of France and Scotland, passed the summer months in 1357. The Estate was held in the later part of the seventeenth century by John Alford." The marriage of his daughter is recorded in the Harleian Visitations. Also London Marriage Licenses "John Clarke, of London, bachelor, 33, and Johanna Alford, spinster, 22, daughter of John Alford, of Clarendon Park, county Wilts, gent, 15 September, 1663."

Election of Officers

Biography: Tressie Bowman

The lady many of us have come to love and know as Tressie Bowman was born 16 January 1899 in Little Rock, Pulaski County, Arkansas. She was the daughter of Leander Lemuel and Mary Pamelia (White) Nash. Leander, called Lee, was born 12 November 1859 in Limestone County, Alabama. Mary was born 12 May 1866 in Aurora, Kane County, Illinois. So Tressie began her life with an attraction for both the north and the south.

By the time she was nine years old the family had moved to Texarkana, Arkansas, where her mother died in March 1908. At that time Tressie had two sisters living: Mary, about 19 years old, and Frankic, about seven. Tressie's father was a railroad man and was gone from home much of the time. Mary did most of the housework and took care of her younger sisters, but in 1910, at age 21, Mary died. Mr. Nash tried to get live-in help but finally gave up and placed Tressie and Frankie in a Catholic convent, Sacred Heart Academy. Neither of the girls were of the Catholic faith; however, their father came home and took them to the Methodist Church as often as he could.

Later Tressie's father married a widow, Josephine (Sheppard) Myers, the daughter of Senator Sheppard from Arkansas. Josephine had her own children, including a set of twins. She owned a small store in Doddridge, or Fouke, Arkansas, and Tressie and all the children had to help in the store. The lady next door had the telephone exchange in her home, and she offered to teach Tressie how to run the switchboard. She later became a telephone operator.

Tres e remembers one of the most thrilling moments of her life as the time she heard news of the Armistice in World War I. She opened all the keys on her switchboard and rang everyone on the exchange so they could hear it from New York. She could hear all kinds of praise and thanksgiving from the mothers of sons who were "over there" and she could hardly see for the tears in her eyes.

While she was working the switchboard, Tressie "met" James Matthew Shull. He was born 24 June 1884 in Sabine Parish, Louisiana, the son of William Levi and Lucy (Maines) Shull.



"Matt" was a bookkeeper for a lumber company which was served by the switchboard. They seemed to fall in love with each other's voices, and although Matt had told her he had only one leg, their "relationship" continued. They finally met in person and were married three months later on 14 Dec 1918 in Texarkana.

After the birth of their daughter Lucy (AAFA DAR Project Officer Lucy Shull Stevens), the family moved to Louisiana where Matt worked in the court house in Minden and was Clerk of Court in Coushatta. Matt went to Jacksonville, Florida, about 1924-25 when the "boom" started. Tressie, her father (who had divorced Josephine), and Lucy followed by train. From there the family returned to Coushatta. Louisiana, where Matt started his own Abstract and Title Company. He later co-owned another similar company in Many, Sabine Parish, Louisiana, which he still had an interest in when he died on 20 November 1934 in Caddo Parish. Louisiana. He is buried in the Bayou Scie Methodist Church Cemetery near Zwolle, Sabine Parish, Louisiana.

Before he died, however, the family lived in several other towns in north Louisiana—wherever thre was an oil boom. During that period Tressie signed on with the Fuller Brush Company and as the only female salesperson led all the salesmen in the six parish area. It was said that she could talk the tail off a donkey and sell it back to him.

Matt died 20 November 1934, after a lingering illness following a stroke. After his death, Tressie and daughter Lucy moved to Shreveport, Louisiana, where Tressie took a job as a practical nurse. In 1935, her sister Frankie's husband was able to get her a job with the American Cotton Co-op Exchange in New Orleans where they lived for a year and a half. When that job played out, they returned to Minden, Louisiana, and Tressie worked in various jobs in and around Shreveport. From there she moved to Dallas, Texas, where she worked for the Reconstruction Finance Corporation (RFC), a government agency established by President Hoover in the early 1930's to aid businesses and home owners with loans.

By that time Lucy had finished high school and business school. When she joined her mother in Dallas in 1939 she

took a Federal Civil Service exam and began to work for the Federal Reserve. In 1941, Lucy received an appointment in Washington D. C. with the government. She moved there and lived with her aunt Frankie and her husband. Lucy met her future husband, Bob Stevens, on her first day of work at the Veterans Administration.

Nine months after their marriage, Tressie could stand it no longer----she moved to Washington to be near her daughter and her new husband. Since Bob went into service just six months after the marriage, Tressie lived for a while with Lucy. Later, she got an apartment in Washington and lived alone. Tressie worked for the RFC in both Dallas and Washington D. C. When the RFC closed, she went to work for the National Naval Medical Center as a library assistant. She retired in 1962. Tressie joined the National Genealogical Society and at one time served as their treasurer and councilor.

Tressie loved to dance, and those who are old enough will remember all the dances held for the servicemen during World War II at the USO, whre Tressie did volunteer work. She met Lewis Orlando Bowman, Sr. at a government dance, and they were married 17 June 1949 in Washington D.C.

Lewis was born in 1904 in Hambleton, West Virginia, and died in 1976 in Bethesda, Maryland. Lewis also liked to dance and they both liked to travel, so they traveled extensively and danced frequently. Lewis was a sail maker and leather worker at the Naval Gun Factory. Needless to say the couple made many genealogy research trips and attended several reunions.

From birth Tressie had an Alford connection. Her mother, Mary Pamelia White, was the granddaughter of Pamelia Sikes. From there she traces her ancestors back through five additional generations of Sikes to Increase Sikes, Sr. who married Abigail

Fowler in 1670. Abigail was the daughter of Joanna Alford Fowler. Joanna was the sister of Benedict Alford and Alexander Alvord, both progenitors of notable New England branches of the family. Tressie is able to trace her Alfords back to the mid-1500's in England.

Tressie's first husband gave her another Alford connection. Matthew Shull's great grandmother was Lucy Alford Maines of Sabine Parish, Louisiana, daughter of Jacob Alford. Jacob, who moved from North Carolina, with a short stay in Georgia, to Louisiana in the very early 1800's, was the progenitor of most of the Sabine Parish Alfords, the Washington and Tangipahoa Parish Alfords, and many of the Alfords of Pike and Walthall Counties in Mississippi.

In July 1970 Tressie published her first issue of the ALFORD FAMILY **BULLETIN.** The stated purpose of her bulletin was to prove the ancestry of Jacob Alford and to learn the connections between the New Kent County. Virginia, Alfords and those of New England. That first issue was a 15 page document with page one being a letter explaining and introducing the publication. The other 14 pages were packed with census data, probate record indexes, abstracts of wills, information from pension applications, deed abstracts and indexes, marriage lists. and a family chart on Jacob Alford and the data applied to a myriad of states. She continued to publish these bulletins, at the rate of about two annually, usually in July and December until the fall of 1979 when she published her final issue. There was a hiatus from December 1971 until July 1976 and some years she managed only one issue. In 1977 she experienced a fire in the basement of her building and lost some of her records. She had cataract surgery in the fall of 1979 and was scheduled for an implant. That, together with other surgery and illness in 1978, and the ever increasing postal rates, nearly ended the bulletin. In 1971 the subscription was \$2 per year, and when she stopped in 1979 the price had increased to \$7. Never did she publish an issue that was not packed with interesting and useful information on Alfords.

While most of her data came from her own personal research, Tressie depended on input from readers for some of her bulletins, and there are names mentioned in the bulletins who are members of the Alford American Family Association today. Some of those noted are Lucille Mehrkam, Rod Bush, Alberta (Arletta) Skillen, Robert S. Barrows, D. L. Alford, Rose Alford Shelton, and Margaret Windham.

Tressie Bowman was the first person to undertake a project which addressed all Alfords in all geographic areas and in all branches of the family. Other important works such as Colonel Harllee's KINFOLKS and Hugh Edwin Alford's IN SEARCH OF MY ALFORD ANCESTORS limit themselves to a small part of the family.

Over the years Tressie researched and collected information on Alfords by the thousands. Data was meticulously entered on individual records—3 x 5 inch slips called pea slips. She also prepared family group records on each family she found. Copies of all of these have been made available to AAFA either by Mrs. Bowman or through her daughter, Lucy Shull Stevens, an AAFA member and the Association DAR project officer. The family group records are available to members from the AAFA library.

As long as Alford descendants engage in research on their family history, Mrs. Bowman will be remembered. They may not use her bulletins or even see her name, but all will be indebted to her for the work she did in pioneering research on Alford family history. As an expression of appreciation for her work, she was the first person to receive a lifetime honorary AAFA membership.

Alfords in the IGI-Nine States

In the December 1989 issue of AAFA ACTION, Alfords from the Alabama 1988 LDS (Mormon Church) International Genealogical Index were listed. In March 1990 those from the North Carolina index were printed. Tennessee Alfords were listed in the June 1990 issue. With 50 states and only four issues of the quarterly each year, you might figure that it will take over 12 years to get all the LDS-IGI listed. Not so! There are some states with few, if any, Alford entries.

From time to time a mixed list will be printed listing the Alfords from those states with few IGI entries. Nine different states have been consolidated in the following list: Alaska, Delaware, Idaho, Illinois, Maine, New Jersey, New Mexico, Oklahoma and Pennsylvania.

In the last issue, the IGI data was supplemented with other data on Tennessee Alfords available in AAFA files (excluding census data). The following list has also been supplemented with Association data. We want to share Alford information that we receive from members or others who submit data to the Association. The format used for the IGI is the best one for that purpose. Rather than initiate a separate section or feature in the quarterly, we will include such information in the IGI list each quarter. When information is being printed from a state with many Alfords in the IGI, it will be kept separate and not "contaminated" with extraneous information.

One small feature has been added in the list in this issue. If information is included on the children of a person listed, a "+" appears before their name. The children will be found elsewhere in the list under a heading showing the parents' names.

Remember: the fact that information is printed in the IGI does not mean it has been proven, and many Alfords are missing from the IGI lists.


