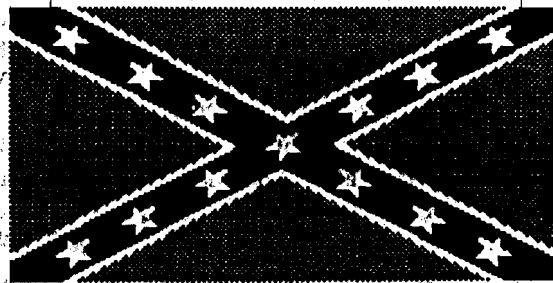

my good meaninge, as this bearer can
acquainte your Lordshipp, who knoweth
and hath seen my troubles. I therefore
humble beseech your Lordshipp
accordinge to your wonted nobelness to
me ward, that you will vouchsafe to
acquainte his Majestie with the
perticulers hereof and entreate his
highness on my behalfe, that he will be
tratically pleased to strengthen my
commission accordinge to his said
Majestie's gracious letter, and signifie the
same under his private seale. That the
place of Governour and the oath of
Councillors may be made known and
distinguished. And whereas I formerlie
humble intreated your honour to move
his Majestie to compassionate my
wantes, which at this time doe oppresse
mee more grievouslie, I beinge thereby
made contemptible soe that (my miserie
pressing mee), I an inforced more
earnestlie to implore your Lordshipp's
aid in regarde towards all my charges in
coming hither and my being here. I have
not received on farthing for my relief.
Thus having laid open to Your
Lordshipp the depth of my afflictions
and the true state of things here, I
humble begg your Lordshipp's assis-
tance, and craving pardon for my
boldness, I rest,
