On Tom Roland Alford's 1918 WWI Draft Registration Card (Ancestry.com), he is age 36, a carpenter living in Hartford, Minnehaha Co., SD. He was born 1 July 1882 [sic], names his wife Bertha Alford as his nearest relative, and says ?left arm weak not strong.?
