

Known Descendants of CLINTON ALFORD

This is not the typical AAFA genealogy. These descendants of Job Alford are from a file created by John A. Rogers, AAFA #0544 who is the AAFA authority on Job Descendants. John has researched these folks to a greater degree than AAFA had researched most other Alfords. John also includes more information in his report than is found in a typical AAFA genealogy.

Nevertheless it is a work in progress and probably is not complete and with some error. Generations 5-7 have been removed to protect the privacy of most of the living. The work contains many names but the only ones listed in the index are those listed within the registry system.

1. **Clinton Alford** #6183 b. 1798, Wake County, N.C. (formerly Bute), (son of Job Alford #325 and Sarah Ann Turner? #326) m. **Martha Slaughter** #6184, b. ABT. 1807, Unknown, d. AFT. 1850, Unknown, buried: AFT. 1850, Unknown. Clinton died ABT. 1845, Columbus (Muscogee County), Georgia, buried: ABT. 1845, Unknown.) Clinton Alford, probable oldest son of Job Alford, was born about 1798 in Franklin County, North Carolina and migrated with his parents to Jones County, Georgia around 1817. That year he showed on the Jones County Tax List, as a minor. In 1818 records show that his father, Job, paid his taxes. In August 1823, Clinton was received into Caney Creek (New Hope) Baptist Church in Jones County. On March 19, 1825 he married Martha Slaughter (?-?), daughter of R. Slaughter, Sr., in Upson County, Georgia, by Thomas Leverett, CCO. Clinton was living in the Redbone District (Land District 10 - LL33) in 1826 (tax list) northeast of Thomaston (near current town of The Rock), but in 1827 (tax list), he moved southeast of Thomaston to the Black Ankle District (494) of Upson County (Militia District 16 - section 87). In 1829, Clinton, along with his father, Job, and brother John Turner, moved west to the Dupree's District (near Daviston) of Talbot County (current Taylor County). In 1830 he was listed as a head of household in the Talbot County, Georgia (Daviston area - now in Taylor County). In 1832 Clinton was granted land in Talbot County in the Cherokee land Lottery. His brother, William Henry Alford, was granted land next door to him. He had two sons between 5-10 years of age and one daughter less than 5 years of age. These two sons were apparently William Henry, named after his uncle, and George Washington (in doubt now as a son). According to just found old letters, the other son of this age would be William Clinton Alford. By 1840 Clinton had moved to Columbus, Georgia (Muscogee County), being on the federal census for Muscogee County in 1840. His residence was in the 5th Ward of the City of Columbus. He was listed with one son under 5 years old (Reuben R.), one son 5-10 years old (probably William Clinton), and one son 10-15 years old (possibly William Henry). He had one daughter between 5-10 (Elizabeth), and one daughter between 10-15 years old (Mary Ann). There is no record of his death, however I estimate it to have been about 1843. On September 23, 1845, a Martha Alford married Jesse Moore in Muscogee County. I believe this to be Clinton's widow, Martha Slaughter Alford. Clinton had no daughters of marrying age at this time, so Martha could not have been a daughter, named after her mother, Martha. There were no other Alfords in Muscogee County in 1840, and the one that was there in 1850 (Ben Alford) was too young to have had a daughter that age. Clinton had the following probable children:

Reuben R. Alford, son of Clinton Alford, was born about 1833 in Muscogee County, Georgia. He grew up in Muscogee County and lived there until moving to

Russell County, Alabama around 1847. In 1850, he is listed as a single man in the household of Seaborn Snuck in Russell County. In around 1857 he moved with his brother and sister-in-law, William and Mary Alford, to Sacramento County, California, where bought and farmed land. In 1870, he and his brother had moved to Solano County. On January 5, 1872, Reuben bought a land patent in Solano County (Township 007N, Range 002E, Section 24). During this decade both brothers moved to Solo County and back to Solano County. By 1880 they had bought farms in El Dorado County, and by 1886 were in Placer County, where, apparently, they lived until their deaths in the late 1890s. Reuben never married or had any children. It is thought that he, like his sister, Mary Ann, and brother, William Clinton, died of consumption (tuberculosis).

(32) William Henry Alford, oldest probable son of Clinton Alford, was born on September 3, 1825 in Upson County, Georgia. By 1840 his family had moved to Muscogee County, Georgia. William's father probably died about 1843. In February 17, 1848 William Henry married Eliza Louviza Webb of Elbert County, Georgia (11/4/1829-11/11/1857) in Muscogee County, Ga., probably in the city of Columbus. Jefferey Oats performed the service. Eliza was the daughter of Fortunatus and Sara Webb, also of Harris County, Georgia. Fortunatus Webb was the coroner of Harris County, Georgia in 1835. Eliza had a first cousin, Phillip Elkane (Elkana) Webb, who was living with William Henry's cousin, William Floyd Alford in 1860. Like William, his Father-in-Law was a Baptist minister. Muscogee County bordered Harris County, where William grew up. In 1849 he left the Harris/Muscogee County, Ga. area and moved to Coosa County, Alabama (north of Montgomery, Al.), where in the 1850 federal census, he was listed as an overseer on a plantation. This move was probably in concert with the move of his father-in-law, Fortunatus Webb, who settled nearby. William also apparently followed Mr. Webb into the ministry. In about 1856 William moved south to Mt. Ida, Alabama in Pike County (current Crenshaw County - just a couple miles north of Brantley), Alabama probably to take over a ministry there. Mt. Ida is about 4 miles northeast of Brantley, Alabama on County Road 41. On November 11, 1857, William's wife, Eliza died in Pike County. William and Eliza had five children together. On November 1, 1858, William received a land patent for 79.64 acres in Pike County (Mt. Ida). On November 16, 1859 William re-married to Narcissus Padgett (b. 1839 in Muscogee County, Ga.) just across the county line in Butler County, Alabama, by the Reverend William C. Avant, husband of Eliza Webb Alford's sister, Samantha Webb. Narcissus was probably the daughter of Craig Padgett, who shows on the Pike County census in 1850 and 1860. William and his family were listed on the 1860 Pike County census. On August 25, 1861 William's 2nd wife, Narcissus, died during childbirth in Butler County, Alabama. She possibly was in the home of her parents in Butler County during this time. After losing his 2nd wife, William married his 3rd wife, Samantha Martha Ann Owens (4/1839-1/28/1921), daughter of William Owens, on February 17, 1863 in Pike County, Alabama. Shortly after marriage, on September 22, 1863, William joined the Confederate Navy and served until the end of the war in 1865. Upon returning from the war, in around 1866, William moved to just across the Pike County line, to Butler County, Alabama. His stay there was short-lived as in 1868 he moved to Walton County, Florida (according to daughter's Civil War pension application), where

he was listed on the federal census as living in the Gaskin/Darlington area. His occupation was a teacher and minister. Here he finally caught up with his uncle, John Turner Alford. In 1870 William Henry was living next door to John Turner in the Limestone area, near Darlington. William Henry was the founder and first minister of Limestone Baptist Church near Darlington, Florida. His cousin, John Francis Alford, was the church clerk. In 1871, church minutes show that he presided over the funeral of his uncle, John Turner Alford. Church minutes also show he was still the minister at Limestone through 1872. In about 1873, shortly after the death of his uncle, John Turner Alford, William Henry moved to the Sandy Creek area of Holmes County, Florida, not far from Lake Cassidy. The move was probably an effort to reside centrally in the middle of all the churches he preached at. In 1878 he was the Pastor of Sandy Creek and New Hope Baptist Churches in Holmes County. Sandy Creek Baptist Church was, by far, the largest church in the area, having 88 members in 1879. In 1879 he took back the additional pastorship of Limestone Baptist Church near Darlington in Walton County. In 1880, he shows on the census in the Sandy Creek area, six houses away from his daughter, Emma, and her husband, Abner Vaughn. Also not far away, were his daughter Alice and her husband, Daniel Smith. In 1880 he was Pastor of Sandy Creek, New Hope, Limestone, and Mt. Zion Baptist Churches in Holmes and Walton Counties. William's brother-in-law (by his first wife), Thomas J. Webb, was the church clerk at New Hope in 1880. Another brother-in-law, William H. Webb, was also active in the area churches as a clerk and messenger. The last mention I have found of William Henry in the Limestone Church records, as minister is August 27, 1881. He was also a Holmes County Commissioner in 1881. He was still the pastor of Sandy Creek and New Hope Baptist Churches in 1881. His son-in-law, Daniel Smith, husband of daughter, Alice Alford Smith, was his clerk at New Hope Church in 1881. Around 1882 William, Samantha, and family moved to Lake Defuniak (current DeFuniak Springs) in Walton County. They were among the first settlers of De Funiak Springs, which was laid out in 1881, and was built during 1882-1883. William shows there on the 1885 Florida State Census as "W.A. Allford". In 1886, he bought lots 1673, 1677, and 1670 from the Lake De Funiak Land Company. His stay there was short, as in 1887, according to his wife's widow's pension, the family moved to Shelby County, Texas, near the town of Spivey (current Paxton), ten miles north of Center, Texas and 2 miles east of Tenaha, on current U.S. Highway 84. Walton County records show that in 1887, William Henry sold his house and lot in De Funiak Springs (Lot 1677 26-3N-19) to Winnie Henderson. The railroad had just been built as far as Shelby County in 1885. William Henry obviously took advantage of the fact he could load his family on the train in Lake DeFuniak and go directly by rail to Texas. William Henry died in Shelby County on October 23, 1897 (on tombstone - "Gone from our home, but not from our hearts"). His burial was at North Jericho Cemetery in Shelby County, about 3 miles south of Paxton, Texas on Jericho Creek (at the end of CR 3671). On June 12, 1900, while still a resident of Shelby County, Samantha, his wife, filed for a widow's Confederate pension, which was granted on July 12, 1900. In 1900 the recently widowed Samantha was listed living as a boarder with Martha Braly in Shelby County, Texas. The census also showed that Samantha had 7 children, with 6 living in 1900. Willie Alford, who was in the same household, (born 10/1889 in Texas) was the son of John Turner Alford, her son. In 1910 Samantha was living with her son, Samuel Bloxcom Alford in Newton County, Texas. At that time 4 of her 7 children were still alive (Samuel, John Turner, Henry Marion, and Sarah Belle). Since six were alive in 1900, two must have died between 1900 and 1910. Samantha M. Alford died on January 28, 1921 of heart disease in Port Neches, Texas (Jefferson County), at the home of her son, Henry Marion Alford, with whom she had moved in with in the summer of 1920. According to her Mortuary Warrant, she was taken by train to Shelby County and buried in an unmarked grave next to her husband at North Jericho Cemetery in Shelby County, one mile east of Tenaha.

AFT. 1880, Lee County, Mississippi, buried: AFT. 1880, Unknown. George died AFT. 1880, Lee County, Mississippi, buried: AFT. 1880, Unknown. George Washington Alford, probable son of Clinton Alford, was born in 1826 in Upson County (possibly Talbot County), Georgia. He grew up in Talbot County and later, Muscogee County, Georgia. In 1840 he lived with his parents in the 5th Ward of Columbus, Georgia (Muscogee County). On December 21, 1847 he married Mahana Elizabeth Page (1820-aft 1880) in Upson County, Ga. She was the daughter of Leonard Page of Upson County. He soon moved his family to Troup County, Georgia, where his first child was born. By 1850 he had moved to Marion County, Georgia (census), just south of his Columbus, Georgia teenage home. In the early 1850s he decided to head west into Alabama, and by 1858 had moved to the town of Tallassee in Elmore County, Alabama. By 1860 he decided to move back closer to home and settled in Russell County, Alabama (1860 census), just across the Alabama line from Columbus, Ga. In 1870 he was still shown in Russell County, but a little farther west in the town of Uchee. Sometime around 1871-72, George and Mahana Alford moved to Lee County, Mississippi. The 1880 Lee County census shows them living in Dwelling 210 of the 94th District. George was a farmer by occupation. With them lived two adult children, Robert Leonard Lafayette, and Sarah Mahana. That is the last I know of him, but George died before 1900.

Mahana: (88) Sarah Mahana Alford, daughter of George Washington Alford, was born in 1853 in Marion County, Georgia. She grew up in Russell County, Alabama during the 1860s, and later moved with her parents to Lee County, Mississippi around 1872. She was still single and living in Lee County with her parents in 1880. On November 17, 1895 Sarah married Carrol Benjamin Mayfield (abt 1854-abt 1925) in Lee County. In 1900 the family shows on the census in Nettleton (Lee County), Mississippi. Whereas, Sarah had no children of her own, she did raise Carrol's son, Edgar, from his first marriage to Mary Sparks, who died in 1893. Around 1905, Sarah and Carrol left Mississippi and moved to Childress County, Texas, where in 1910 they are shown on the census. Carrol worked as a railway car carpenter for a railroad company. In 1920, they were still living in Childress County. Carrol died sometime around 1925, as in 1930, Sarah had moved into a hotel/boarding house in Ellis County, Texas, where she was listed as a widow. Sarah died around 1935.

4. **William Clinton Alford** #15651 (1.Clinton¹) b. 1827, The Rock (Upson County), Georgia, m. **Mary C. ?** #15655, b. 1828, Alabama, d. 24 Oct 1879, Sacramento (Sacramento Co), California, buried: 1879, Old Sacramento City Cemetery. William died ABT. 1897, Placer County, California (probably), buried: ABT. 1897, Unknown. William Clinton Alford, probable son of Clinton Alford, was born about 1827 in The Rock, Upson County, Georgia (from Placer County, Ca. voter registry 1892). He moved with his parents to Talbot County in about 1829 and around 1833 to the city of Columbus in Muscogee, Georgia. William Clinton spent his teen years in Columbus. His father, Clinton probably died around 1843, as Muscogee County marriage records indicate that his mother, Martha Slaughter Alford remarried Jesse Moore in 1845. As a young man, William Clinton moved across the Chattahoochee River into Russell County, Alabama, where in 1850, he was living as a single man in the household of Allen Chapman. Sometime around 1856, he married his wife, Mary C. ? (1827-abt 1873) in Alabama. The couple soon moved across the country and settled in Franklin (Sacramento County), California. Shortly after their arrival, in 1857, their one and only child was born. The California census of 1860 shows William still in Sacramento County, with his wife, child, and brother, Reuben R. Alford. Prior to 1870, they moved out to nearby Solano County, California, where both Reuben and William Clinton farmed. William bought a land patent on January 5, 1872 in Solano County (Township 007N, Range 002E, Section 24. William's wife, Mary, died of consumption (tuberculosis), after fighting it for years, on October 24, 1879 in the city of Sacramento, California. She is buried in the Old Sacramento City Cemetery. During this decade William and Reuben moved to Yolo County for a time, but came back to Solano County. In 1876 he was living in the City of Sacramento. By 1880, both Reuben and William had moved to Greenwood in El Dorado County, California where they also farmed. William was listed in 1880 as a widower. Both brother's later moved to the town of Allens in Placer County, California, just north of El Dorado County by 1886. Both of them were listed on the Placer County voter registry in 1886, 1890, and 1892. William probably died around 1897 in Placer County, as he cannot be found in the 1900 census or 1910 census. It is thought, judging from old letters he and his wife wrote, that he too suffered from tuberculosis. William and Mary Alford apparently had only one child:

She grew up there and later in Muscogee County, where on June 1, 1851 she married John Clarke (5/5/1826-1873). The couple soon moved to Haywood County, Tennessee, where they lived until around 1857, when they settled in Pine Bluff (Jefferson County), Arkansas. They are listed in Jefferson County in 1860. Sometime before 1870, John and Mary moved back to Tennessee. Mary died, possibly of consumption (tuberculosis), on May 4, 1871 in Haywood County, Tennessee. Mary and John Clark had the following children: John Peter Clarke (3/7/1852-1905), Victor Perrin Clarke (1/13/1854-?), William Andrew Clarke (1/27/1856-?), James Buchanan Clarke (6/22/1858-?), Mary Martha "Mattie" Clarke (8/11/1860-?), Charles Rosemund Clarke (10/7/1863-?), Nancy Clarke (2/2/1867-?), and Neill Clarke (7/29/1869-?).

8. **William Lafayette Alford** #1109 (2.William², 1.Clinton¹) b. 22 Feb 1849, Coosa County, Alabama, m. **Ursula "Sula" Moore** #1128, b. 26 Jan 1842, Georgia, (daughter of Lovell Moore #8937 and Elizabeth ?? #8938) d. 1920, Holmes County, Florida, buried: 1920, Sandy Creek Cemetery in Holmes County. William died 10 Dec 1918, Sandy Creek (Holmes County), Florida, buried: 12 Dec 1918, Sandy Creek Cemetery near Ponce, Florida. William Lafayette Alford was born on February 22, 1849 in Coosa County, Alabama. He grew up in Coosa County and later in Pike County, Alabama. Having lost his mother, Eliza, in 1857 at the age of 8, he was living with his second stepmother, Samantha. In 1868 William moved to Walton County, Florida with his parents, living next door to his Great Uncle John Turner Alford. In 1871 he married Ursula Moore (1/26/1842-1920), daughter of Lovel (1795-1878) and Elizabeth Bennett Moore, (b. Randolph County, Ga.) in Walton County, Florida and soon moved to the Lake Cassidy area of Holmes County, not far from Ponce de Leon. His homestead was about one mile west of Sandy Creek Baptist Church, on the dirt road. William Lafayette showed on the 1885 Florida State census for Holmes County, living next door to his sister Alice Booney Alford Smith and brother-in-law, Daniel Smith. A farmer, by occupation, he was still there in 1900 according to the federal census. The 1910 census shows him and his wife, Ursula, living next door to their son, William Chorner Alford, on the Scott's Mill to Westville road. Their other son, Lovel Ezra Alford, lived two houses away. Both daughters had died while giving birth to their first child. William Lafayette, a literate man, died on December 10, 1918 (death certificate) in Holmes County at home near Bridge Creek. Leslie Davis, a cousin of this author, a childhood neighbor, relates an interesting story about "old Mr. Alford." Around 1917, a year before his death, William Lafayette was traveling in his buggy on the Limestone to Red Bay road and got stuck in the mud. Leslie's mother sent him (age 7 at the time) to help him out. William Lafayette's wife Ursula, known as "Sula" died in Holmes County in 1920, at 78 years of age, and is buried at Sandy Creek Cemetery in Holmes County. Her death would have been after February of that year, as she had given an oil lease to some of her land on February 3, 1920 to the Oklahoma Star Refining Company. "Sula" had moved to Walton County in 1850 with her parents and siblings. Her brothers, Lovell, Ezra, William, George Washington, and John S. also settled in Walton County. She was listed on the 1920 Holmes County census as a widow, living with her son, Charles Lovel Ezra Alford, in the Bridge Creek Precinct, near Ponce de Leon. According to death certificates, both were supposedly buried at Sandy Creek Baptist Church Cemetery, but the graves cannot be found.

The couple shortly moved to the Lake Cassidy (Sandy Creek) area of Holmes County, Florida, apparently due to the move there by Emma's parents. From 1878-1880, Emma's brother-in-law, John Angus Vaughan, served as clerk of New Hope Baptist Church, under her father, William Henry Alford. In 1880, the federal census shows them living six houses away from Emma's parents in the Sandy Creek community. By 1900 (Federal Census) the couple had moved to the Matthew's Mill community (near New Hope) of Holmes County near the Alabama line off of Highway 2. In about 1872, Alice, a literate woman, married Daniel Smith (1/16/1852-1/22/1935) in Holmes County. They set up their homestead in the Sandy Creek area of Holmes County immediately after marriage. In 1880 (federal census) the couple still lived in the Sandy Creek area of Holmes County, not far from her sister, Emma, and her father William Henry Alford. Her cousin Jane Alford Tadlock and her husband Benjamin lived two houses away. In 1885 (state census), Alice and Daniel Smith were living next door to William Lafayette Alford, Alice's brother, who had taken over his father's land. William Henry Alford had gone to Lake Defuniak in Walton County around 1882. From 1881 to 1885 Alice's husband, Daniel Smith, was the clerk at New Hope Baptist Church in Holmes County, serving for a while under his father-in-law, William Henry Alford, the pastor. Sometime in the early 1890s (after their last child was born), the family moved to Bristol, Florida (Liberty County), just southeast of Holmes County. He was named after his maternal uncle, Thomas James Webb. In 1868 he moved with his parents to Walton County, Florida (Limestone). In 1873 he moved with his family from Walton County to Holmes County, Florida in the Lake Cassidy area. Thomas James married Catherine W. Neal (9/9/1844-2/9/1909) in 1876 in Holmes County. Catherine was the daughter of David and Margaret Neal of Holmes County. David Neal was the Church Clerk at Sandy Creek Baptist Church under Thomas's father, Rev. William Henry Alford, from 1878-1880. The family shows on the 1880 Federal Census for Holmes County. Family legend says that in around 1886 James headed for East Texas, apparently leaving his wife and children in Florida. Catherine, James's wife, was shown living near Westville, Florida (Holmes County) in 1900 as head-of-household, with her two children. She died February 9, 1909 in Holmes County, and is buried at the Westville City Cemetery. Thomas James moved back from Texas, to the New Hope area of Holmes County, in the early 1900's. It is not known whether or not he rejoined his wife, Catherine. On November 16, 1917, Thomas sold land to T.J. McDade in Holmes County. On October 7, 1918, in Holmes County, James married Lena Simmons (8/27/1879-1959) of Westville and settled in Westville after marriage. Lena was born, Eva Lena Stanton, daughter of Chalmers Stanton and Icie Lavenia Rikard Stanton of Westville. Her first husband was Joseph Simmons, who died around 1912. Thomas James "Tom" Alford was shown on the federal census, as living in Holmes County, Florida with Lena in 1920. He also had four Simmons stepchildren (Charles "Charlie" Simmons b. 1904, Hollie Simmons b. 6/2/1903, Ira Simmons b. 10/9/1907, and Mabel Simmons b. 1911). There was an apparent divorce around 1928, as in 1930 Thomas James was living in New Hope, Florida with his nephew, Oscar Vaughan, son of his sister, Emma Alford Vaughan. Thomas James Alford died on August 20, 1931 (death certificate) in Holmes County. His step-grandson, Thomas Simmons of New Hope, Florida says he

remembers "Tom" Alford riding him around in a wagon in the early 1930s. At the time of death, his residence was listed as No. 1 Florida Route 2, just inside the Alabama line. His doctor was J.W. Beasley of Geneva, Alabama. According to his death certificate, Thomas was involved in the grocery business. He was buried at the Mt. Ida Cemetery (grave unmarked) near New Hope, Florida in Holmes County. Lena Alford is buried at Westville Cemetery with her first husband. Thomas James had no children with Lena.

In 1920, William was listed on the federal census as a boarder of Julian Coeey in Holmes County. By the 1930 census, he had moved to Taylor County, Florida (Pleasant Hill), where he boarded with Charles Brown. He soon became a railroad worker, a lifetime occupation in which he retired from in the late 1940s. In later years William lived in Perry, Florida (Taylor County). The couple is shown living in the New Hope Community in Holmes County (state census) in 1885. At that time, Marie's brother, Henry Marion Alford, was living with them. John Turner Alford, son of William Henry Alford, named after his Great Uncle John Turner Alford, was born on April 16, 1867 (bible birthdate - tombstone says 1868) in Butler County, Alabama. Soon after birth his parents moved to Walton County, Florida, where he grew up, along with Holmes County later on, after their move there in 1873. In 1882 he and his family moved back to Walton County, where they settled in Lake De Funiak (current De Funiak Springs). He lived here until 1886, when he moved to Shelby County, Texas, as a teenager with his parents. The family settled down just north of Center, Texas at Paxton (Spivey). On December 14, 1889 he married Edna Alice Latimer (1/18/1870-10/13/1945 / b. Desoto Parish, La.), of Joaquin, in Shelby County, where they became members of the newly created Pine Ridge Missionary Baptist Church, five miles southwest of Joaquin. John's father, Reverend William Henry Alford, performed the service. For reasons unknown at this time, John left his wife and three young sons in June 1895. In 1900, one of his sons, William John "Willie" was living with his maternal grandmother, Samantha Owens Alford, who was living in the household of Martha Braly in the town of Paxton, Texas (Shelby County). The other two children stayed with Edna, their mother. John moved around for a couple of years and settled in nearby Timpson, Texas in 1898, where he lived, possibly with his brother, Julius Charles, for six months. In 1898 he joined the Army at the onset of the Spanish-American War. On June 9, 1898, John wrote a very well written and articulate letter to the Timpson Times from his station in Mobile, that gives a lot of personal information about him. After the war, he traveled around Texas, but eventually settled in Beaumont, where in 1923 he lived with his second wife, May R. Alford, at 1195 Laurel Avenue. At this time he was a truck driver for the Houston Construction Company, the same place his nephew, Robert Lee Milam, Jr., worked. John Turner also sold real estate on the side, as on April 19, 1923, he place an advertisement in the Port Arthur News about lots for sale in the Port Neches area. He had set up his own company, the John T. Alford Land Company. He may have chose Beaumont because his his sister, "Belle" Alford Milam lived there, and his brother, Henry Marion Alford, lived in nearby Port Neches. On March 17, 1909, Edna, his former wife, sold 137 acres of land in Shelby County. The 1927 Beaumont Directory shows John Turner living at 2715 Concord Street. He died later that same year, and his occupation at time of death was listed as a real estate agent. Much of this information came from Doris Alford, granddaughter-in-law of John Turner. John Turner became a member of the Knights of Pythis, a fraternal organization, in the late 1890s. John Turner died on May 28, 1927 in Bexar County, Texas, and is buried in the Knights of Pythias Cemetery in Beaumont, located at the corner of Pine Street and Mueller Avenue. That cemetery has now been taken over by St. Michaels Orthodox Church. According to his death certificate, he died of "acute indigestion" while vacationing at a Breckenridge Park tourist camp in San Antonio (Bexar County). He was listed as married at the time. His death certificate had his age wrong and appeared to guess at most of his information. He obviously had family who straightened out this information for his burial back in Beaumont. Edna Latimer Alford, John Turner's first wife, died on October 13, 1945 in Abilene, Texas, at the Epilepsy Hospital, and is buried at the Truitt

Family Cemetery six miles south of Joaquin, Texas (Shelby County).

In 1900 he was still living with his grandmother, Samantha Alford, in Shelby County, where they both boarded with Martha Braly. He was no longer living with his grandmother or mother in the 1910 census, so he was living on his own somewhere as a twenty-one year old. Not much is known of "Willie", but he later worked for the Western Union Telegraph Company. After spending Christmas of 1916 at home in Texas, he arrived in Douglas (Cochise County), Arizona on January 3, 1917 to do work for Western Union. He fell ill on January 9, 1917 when he was taken to the local Calumet Hospital. He died as a single man nine days later on January 17, 1917, and was buried on January 27, 1917 in Douglas, and is buried in the City of Douglas Cemtery. Nothing further is known of him.

Henry died 3 Jan 1924, Port Neches (Jefferson County), Texas, buried: 6 Jan 1924, Ramah Cemetery in Teneha (Shelby, Texas. Henry Marion Alford, son of William Henry Alford, named for his father, William Henry, and 2nd cousin, Francis Marion Alford, was bom on May 5, 1868 in Walton County, Florida. He moved with his parents to Holmes County around 1873, just next door to Walton County. In 1885 (state census) Henry, a railroad worker, had moved from home, and was living with his sister, Susan Marie Antoinette, and her husband, Ruben Davis, in the New Hope community of northem Holmes County. In 1886, Henry Marion, along with his parents, moved to the small community of Paxton (Shelby County), Texas, apparently taking advantage of Henry's job with the railroad, which was just completed to Shelby County in 1886. Paxton (also known as Spivey for a while), was located on the railroad, just outside of Teneha. On February 18, 1890, in nearby Caddo Parrish, Louisiana, Henry married his wife, Lela Estelle Sandlin (6/9/1872-11/5/1958), daughter of Reverend Jesse B. Sandlin and Lela Elizabeth Latimer, a fellow minister of Henry's father, William Henry Alford. On July 18, 1892, Henry bought 45 acres of land from a Mr. Brown in Shelby County (Paxton). He bought another 25 acres from G.A. Hayden on January 2, 1895, and 50 acres from E.D. Bradham on January 14, 1899. Henry's father, William Henry, passed away in 1897. On January 14, 1899, Henry sold 25 acres to E.D. Bradham. Henry Marion, a carpenter by occupation, was living still in Shelby County, Texas, in 1900, according to the federal census. At this time he was raising the children of his apparently deceased sister, Susan Marie Antoinette Alford Davis. On April 10, 1901, Henry bought land from L.C. Bussey and on December 14, 1903 from W.W. Newby. Again on February 3, 1906, Henry bought land from J.W. Paxton. Henry sold one acre to Lillie Alford, his sister-in-law and widow of his deceased brother, Julius Charles Alford, on October 11, 1906. On February 26, 1907, Henry bought 50 acres of land from J.B. Burns, but on the same day, sold 50 acres to Jacob Patterson. Henry and two of his children, Smithie and William Earl, sued the Houston East and West Texas Railrod Company in Shelby County Civil Court, but lost. Henry sold 45 acres of land to C.L. Jopling on February 9, 1913. On January 16, 1917, Henry sold apparently his last land holding in Shelby County, setting up the move of him and his family to Liberty County. By 1918,

Henry had moved his family to Hightower, Texas (Liberty County). according to his son's draft card, however in 1919, Henry and family moved to Port Neches, Texas (Jefferson County). On May 20, 1919, he bought lots 12, 13, and 14 of block 9 in the new Bigelow Addition in Port Neches. Henry's ailing mother, Samantha Alford, died at his home at 921 Block Street near downtown Port Neches. Henry received the mortuary account to bury his mother and assumed the responsibility to pay any indebtedness of his mother. On April 6, 1921, Henry bought lots 10 and 11 on Block Street, and on May 13, 1921, lot 9. On November 9, 1923, Henry sold lots 10 and 11 to his son, William Earl Alford. Today, the Missionary Baptist Church of Port Neches sits where Henry's old house did, at the corner of Block and Grigsby. On January 3, 1924, Henry Marion Alford died in Jefferson County of heart disease. His attending doctor was Dr. Welch, who had also been his mother's doctor. He was buried at Ramah Cemetery ½ mile east of Tenaha on US Highway 84 in Shelby County, Texas. His tombstone reads "His toils are past, his work is done." On January 8, 1924, days after Henry Marion's death, Henry's children and heirs, sold the house at 925 Block Street to Lela to live in. Lela lived here on Block Street in Port Neches until September 26, 1927, when she sold the house to Dick Sandlin, a relative. Lela Alford, in the summer of 1928 (daughter's obituary), moved to Houston, Texas, along with her children, Iva Dell and William Earl (with wife and son). In 1928, Leila shows in the Houston Directory, living at 2010 Jackson Street. Daughter Mamie Estelle Duplissey, husband, and children also lived with Lela at the boarding house. By April of 1930 she had moved to 1628 Pierce Avenue, where she rented rooms out. The 1930 census shows her as a widowed head-of-household on Pierce Avenue (current Pierce Street), running a boarding house. She had her adult children, grandchildren (Claude and Marion Duplissey), and her father, Jesse Sandlin living with her. The last mention of Lela in Houston was in the 1935 city directory, living in her home at 2412 Travis Street. In her later years, around 1936, she moved to Groves, Texas, where she lived at 7061 Henry Street (current name) until her death. On July 8, 1938, Lela received a visit at her home in Groves from her sister-in-law, Mrs. Eva Sandlin of Mandeville, Arkansas. Lela went to Houston on September 14, 1938, to be at the bedside of her son-in-law, Jesse Harris, who was having emergency surgery at St. Joseph's hospital. On September 26, 1938, Lela received a visit from her daughter-in-law, Mrs. William Earl Alford of Overton, Texas and her grandson, William Earl Alford, Jr., age 9. On September 11, 1939, Lela visited her son, Claude Brantley Alford in Aransas Pass, Texas. On June 1, 1940, Lela, accompanied by son, Claude Alford, visted friends and relatives in Joaquin and Tenaha, Texas, in Shelby County. On August 24, 1941, Lela returned home to Groves after visiting relatives, in Corpus Christi, San Antonio, Huntsville, and Shreveport, Louisiana. On March 22, 1955, she returned from Huntsville, Texas, after visiting her daughter, Smithie Harris for several weeks, but soon after that, on March 25, 1955, the Port Arthur Newspaper stated that "Mrs. H.M. Alford" was visiting her son Claude in Aransas Pass, Texas. Lela, according to grandchildren, loved Coca Cola. Lela died of heart failure brought on by arteriosclerosis on November 5, 1958 in Walker County, Texas (Huntsville), at Huntsville Memorial Hospital, while staying with her daughter, Smithie, and is buried next to her daughter Ida Dell Alford Loftin and her husband, Marion Loftin, at Ramah Cemetery in Shelby County.

In 1886 "Charley" moved to Shelby County, Texas with his parents. He married Lillie Brown (1876-?) on February 25, 1895 in Shelby County, Texas. On January 1, 1896, "Charley" bought 65 acres of land from E.S. Hicks in Shelby County. In 1900 the family was listed in Shelby County (near Paxton) living next door to his brother, Henry Miles Alford. Charley was listed as a sawmill laborer. Living with them at this time, was Mirtie Brown, his wife's sister. Around 1903 he moved to Timpson, a few miles northwest of Center. "Charley" died on December 22, 1905 in Shelby County. He is buried at Woodlawn Cemetery in Timpson, Texas (Shelby County). His tombstone has an incorrect birthyear (1878 - family bible says 1872). On October 11, 1906, Lillie bought one acre of land from her brother-in-law, Henry Marion Alford. She sold this land on January 1, 1910, eighteen days before she remarried on January 28, 1910 to F.B. Sarah Belle Alford, daughter of William Henry Alford, was born in Holmes County, Florida (Sandy Creek) on September 10, 1878. After a short stay in Lake Defuniak, Florida (1882-1886), in 1886 she moved with her parents to Shelby County, Texas, where she grew up. On December 24, 1897, "Belle" married Robert Lee Milam (8/21/1866-5/20/1945 / b. Charleston, Miss.) in Desoto Parish, Louisiana. The 1900 Federal census show the family living in the 5th precinct of Shelby County, just 5 houses away from her brother, Julius Charles Alford and 6 houses from her brother, Henry Miles Alford. By 1910 (census), the family had moved to the city of Center, Texas (Shelby County), where Robert Lee was an insurance salesman. In 1915 Sarah Belle and Robert moved to Beaumont (Jefferson County), at 1095 Orleans Road, where she lived until her death (according to her death certificate). I cannot find the family anywhere after the 1910 census, however, Robert Lee, Jr. shows as registering for the WW1 draft on September 12, 1918 (he was actually already in the Army as a mechanic) in Beaumont and the family shows up in the Beaumont City directories in the 1920s. In 1920, Robert Lee and Sarah Belle were living in Beaumont at 376 Wall Street, where Robert Lee was a Special Deputy to the WOW. Their children all lived with them still. Charles was a fireman, Robert Lee, Jr. was an automobile mechanic, Murner was a plumber, Louis "Louie" was in school, and their daughter, Elizabeth (Dollie) worked at the American Printing Company as a bookbinder's

helper. Sarah Belle and Robert Lee Milam divorced around 1921, as in 1923 Belle shows living as a house-head in Beaumont, at 362 Forsythe Street, where she ran a boarding house. Also, according to his mother's obituary, Robert Lee, Sr. was living in New Orleans in 1921. Robert Lee later remarried to Nancy L. ? (?-?). Charles, Dollie, and Louie all lived with her, but Robert Lee, Jr. was living alone, unmarried, at 944 Forrest Street, where he worked as a mechanic for the Houston Construction Company in Beaumont. In 1927, and again in 1929, the city directory has "Belle" living at 861 Calder Avenue, where she was the manager for Crosby Barber Shop & Beauty Supply Shop in Beaumont. Robert Lee, Jr. was a watchman at the Neches Lumber and Building Material Company. By 1929, Robert Lee, Jr had married Nettie ? (?-?) and was working for the Beaumont Motor Company. In 1930, Charles Milam moved to Port Arthur, where he lived at 2200 Proctor Street until his death in 1935. According to "Bill" Alford, son of Jeremiah Alford of Limestone, Florida, Sarah Belle went back to visit her birthplace of Walton County, Florida in 1931. She had other relatives with her. According to Jeremiah, through his son, she was very interested in seeing the old mill of Francis Marion Alford and the old homestead of John Turner Alford at the Five Points area in Geneva County, Alabama. In the 1933 Beaumont City Directory, there is a Robert Lee Milam, with his wife Nettie, listed as living on Magnolia Street, but there is no Sarah listed. It could be that "Belle" was living with her son and his family Robert Lee was a foreman at the Beaumont Motor Company. On December 18, 1935, Charles Milam, Belle's son, died in car wreck near Nederland, Texas. Official cause of death was a skull fracture. He was pronounced dead at St. Marys Hospital in Port Arthur. In 1940, the year of her death, Belle was renting a house at 495 Magazine Street in Beaumont. Her son, Robert Lee, Jr., lived at 3 West Cole Avenue in Beaumont, and was employed as the service manager at O'Quin Motor Company. On Spetember 26, 1940, Sarah Belle visited her sister-in-law, Lela Alford and her nephew Henry Alma Alford in Groves, Texas. The family was planning the marriage of Belle's great niece, Helen Belle Alford, to John Domec. Soon after that visit, Sarah Belle died of heart disease at her home of 575 Walnut Street on November 5, 1940 (death certificate) in Beaumont. The informant on Sarah Belle's death certificate was her son, Robert Lee Milam, Jr. Funeral services were held at Roberts Funeral Home in Beaumont. She was buried in Magnolia Cemetery on Pine Street in Beaumont. Her former husband, Robert Lee Milam died 5 years later at Hotel Dieu Hospital in Beaumont. He was buried at Forest Lawn Memorial Park Cemetery in Beaumont. Sarah Belle and Robert Lee had the following children: Robert Lee Milam, Jr. (9/14/1899-9/29/1943 / b. Shelby Co., Texas / m. Nettie M. ?), Charles B. Milam (12/20/1902-12/18/1935 /b. Shelby County / m. Mary ?), Merner Milam (1903-aft 1923 /b. Shelby County), Elizabeth Belle Milam (1906-aft 1927 / b. Shelby County), and Louis "Louie" Milam (1908-aft 1927 / b. Shelby County).

Alford, was born on August 11, 1880 in Holmes County, Florida, near the Sandy Creek area. He grew up there and also in Lake DeFuniak, Florida, where his family moved to in 1882. He was shown on the 1885 Florida state census with his parents in Lake DeFuniak. He moved to Shelby County, Texas with his parents in 1886. Samuel grew up in Shelby County, Texas, but in 1898, he left home and settled a few miles south in Deweyville, Texas (Newton County). Deweyville was a sawmill town basically founded when the Sabine Tram Company built a large sawmill there in 1900. In 1900, Samuel was boarding with a man named W. George Smith and worked in a livery stable. In about 1902, he married Ethel Murray (1885-? / b. Oklahoma). In 1910 (federal census) he was still a resident of Newton County, Texas, living with his children, his widowed mother, Samantha M. Owens Alford, and his niece, Lenora Alford (daughter of his deceased brother, Julius Charles Alford). It appears, with children being born both in Louisiana and Texas, that Samuel moved around a lot in the early 1900s along the border area of the two states. He probably followed jobs in the timber or oil industry in the area. In about 1908 Samuel had left his wife and there was an eventual divorce. In early 1918, he married Marie "Mittie" Sims (1895-bef 1952). On September 12, 1918, Samuel registered for the draft at Newton, Texas. His nearest relative was listed as Mittie Alford. He and his new wife showed in Newton County in the 1920 census. His occupation at the time was that of being a foreman at a sawmill, owned by the Sabine Tram Company in Deweyville. He was described as having dark brown hair and blue eyes and was of medium height and build. In 1930 the family still lived in the town of Deweyville located on Highway 87. They apparently lived in there until 1936, when Samuel moved his family south to Beaumont, Texas (Jefferson County). Samuel became a member of Calvary Baptist Church. He lived at 119 East Lucas Drive in Beaumont for most of the rest of his life. His death occurred while residing at Schlesinger's Nursing Home in Beaumont, where he suffered from hypertension for years. For most of his years in Beaumont, he was an engineer with the Sabine Tram Company, but turned to gardening during retirement. On June 8, 1952 he died of a cerebral hemorrhage in Beaumont. He is buried in Forrest Lawn Cemetery in Beaumont. His wife, Mittie Sims Alford, had died prior to his death. Samuel's middle name of "Bloxcom" was discovered from his WW1 draft registration in Newton County, Texas.

There seems to have been a close connection between the Slaughter and Towns families in Talbot County, Georgia during the early 1800's. It is my hypothesis that Martha Slaughter Alford's mother was a "Towns". In 1870 "Towns" Alford, still a bachelor, was living in Glenville (Russell County, Alabama), according to the census. With him were living four (4) female Alford's, none of which were siblings. One hypothesis would be that they might have been cousins or, possibly siblings of his father. These were Sarah (age 30), Lucy (age 25), Mary (23), and Emily (age 20). In 1871 he moved to Walker County, Alabama, near Dora, where he met Sarah C. "Sally" Mooney (12/1853-12/12/1893) of Arkadelphia (Cullman County, Alabama). About this same time, his parents and siblings moved to Lee County, Mississippi, near Tupelo. "Towns" Alford made a living by travelling far and wide as a laborer in the timber industry. He must have carried her with him on one of his expeditions to Yalobusha County, Mississippi, as they were married there on January 7, 1871. His wife soon returned to Dora, Alabama (Walker County) to give birth to their first child, Della. I do not know about their living arrangements until about 1882, as the next child was not born until then in Yalobusha County, near Coffeerville. On June 3, 1891, George bought land near Coffeerville, where the couple lived there until their deaths. "Towns" made his living as a day laborer and lumberjack. Sarah, his wife, died on December 12, 1893 in Coffeerville. George Towns died on November 18, 1900, also in Coffeerville. Both are buried in Coffeerville.

On February 3, 1920, he gave oil rights to some of his land to the Oklahoma Star Refining Company. The census that year shows him living next door to his sister-in-law, Hattie "Alford" Hardy, and her second husband, Jesse Hardy. Her first husband, William Chorner Alford, Love's brother, had died in 1911. Love's nephew and niece, Millard and Annie Alford, also lived next door. Apparently, Jesse Hardy had moved in with his new wife at her established home. On November 2, 1922, "Love" sold land to Calup Ledden. In about 1927, "Love" and Rebecca moved to Polk County, Florida to farm. He stayed there until 1930, when he moved back to the area and settled at Eucheeanna in Walton County. On October 6, 1912, Luther married Georgia Duke (12/14/1893-7/16/1951) of Teneha, Texas, in Shelby County. On June 5, 1917 he and his brother, Fred Eugene, registered for the WW1 draft at Joaquin. In 1911, Smithie married a Charles Henry Schmitt (2/11/1882-1918) of Lancaster, Pennsylvania. After marriage, they moved to Los Angeles County, California, where Smithie's second child, Marguerite, was born. In 1912 they were living at 1723 Maple Avenue in the city of Los Angeles. "Henry", a painter by occupation, registered for the WWI draft in 1918 in Los Angeles. At that time the couple was living at 6311 South Main Street in Los Angeles. Charles Henry died shortly after entering the Army (abt. 1918), but not sure if it was combat or the Spanish Influenza. After his death, Smithie moved back to Texas prior to 1920, settling in the Port Neches, Texas area of Jefferson County. In 1920, Smithie, listed as a widow, was living in Port Neches on Atlantic Road near the Groves, with her two daughters, Leila Parkman and Marguerite Schmitt. According to the census, Smithie worked in or owned a restaurant at that time. Smithie's brother, Henry Alma Alford, and his young family lived with, as renters, Smithie and her young girls. In about 1922, Ola married her third husband, William Bishop Futch (7/29/1884-12/5/1951), but were divorced in 1926. Mr. Futch, a pool-hall owner, remarried to Iva Jordan in 1928. In 1925, Smithie's oldest daughter, Leila Henrietta Parkman, died of Bright's Disease, a kidney ailment, according to Smithie's adopted daughter, Earline Harris. Smithie and William Futch had made their home in Orange County, just north of Jefferson County. In 1927, according to the 1930 census, Smithie married her fourth husband, William Jesse Harris (6/16/1898-3/30/1977). In May 1930 Smithie and Jesse Harris were living in Hobbs (Lea County), New Mexico (census), where Jesse worked as a welder in a oil field. By July 1930 the couple had moved to Houston, where both lived with Smithie's mother, Lela Alford, in her boarding house at 1628 Pierce Street in Houston. By 1938 Smithie and Jesse Harris had moved to Overton, Texas, near her brother, William Earl Alford. Here they lived in an oil field camp. On October 14, 1938, Smithie and Jesse returned home to Overton after a visit to Groves, Texas to visit her mother Lela Alford, and other relatives. Shortly, around 1939-40, Smithie and Jesse settled in Segno (Polk County), Texas, where they lived until 1951. In 1942, Smithie and Jesse took in her great niece, Earline Phillips, daughter of her niece, Doris Marie Alford Phillips. They eventually adopted her and changed her last name to Harris. In 1951 the family moved to Huntsville (Walker County), Texas, where they lived south of town on Hwy. 75, until their deaths. Here they farmed and raised crops such as cotton and watermelons. Smithie's granddaughter, Pat Share Byrd,

said that Smithie worked hard in her garden and raised chickens, and she really liked her car. She was a good cook, specializing in fried chicken and berry cobblers. She was also devoted to her husband, Jesse. Jesse worked in the oil business and made a substantial living. Smithie was known to be overly superstitious and liked a good beer. Smithie, who spent some of her early adult life working as a fortune teller, died on February 3, 1977 in Huntsville (Walker County), Texas and is buried next to her husband at Black Jack Cemetery just south of Huntsville. Smithie had the following children by John Daniel Parkman: Lela Henrietta Parkman (10/10/1908-9/9/1925 / b. Texas / d. On December 9, 1912, Henry married Flora Belle Stockwell (1897-10/21/1983 / b. Michigan) in Waller County, Texas. Flora Bell was born, Flora Bell Hartwick, but after her parents died and left her an orphan. She was adopted by Edwin Stockwell, a carpenter, and his wife, Francis, in Ionia County, Michigan as an infant. Edwin moved from Michigan to Waller County, Texas between 1900 and 1910. By 1917 the family was living in Hightower, Texas (Liberty County), near his parents and brother, William Earl Alford. He registered for the WWI draft at Hightower on June 5, 1917. At this time he worked for an unknown oil company. On May 27, 1921, the Port Arthur News wrote that Henry had returned home from the oil wells of El Dorado, Arkansas after an extended stay. On June 19, 1922, Henry bought Lot 23 and 24, Block 3 in the Groves. In 1923, Henry began a long career with the Atlantic Richfield Company, where he advanced to plant superintendent. That same day, he sold two lots of land in Port Neches to Henry Christ. In 1930 (census), Henry and family were still living Port Neches on the Atlantic Refinery Road. Just a few blocks away, his brother, Claude Brantley Alford, lived on Cleveland Avenue. At this time, Henry was working as a yard foreman for the Pure Oil (later Atlantic Richfield) refinery. On November 22, 1936, Henry served as an honorary pall bearer at the funeral of fellow Atlantic Pipeline Company employee, T.D. Lambert. By 1937, Henry's mother, Lela Alford, had moved in with

him and his wife. On March 3, 1938, Henry bought Lot 5, Block 1 in Country Club Estates on Henry Street in the Groves. On January 10, 1939, Henry's grandfather, Reverend Jesse Bryant Sandlin, died at Henry's home in Groves at age 91. In a rare visit, Henry was visited by his first cousin, Amos Alford, son of his Uncle Samuel Alford, and family from Chicago on August 8, 1941. It is said that Henry was a good man and highly admired by the community. After retirement from the Atlantic Richfield Company, in 1952, he moved to near Henderson (Rusk County), Texas, where he owned a large farm. Among his crops were watermelons. His brother, William Earl, ran a grocery store nearby in New London. Henry was an avid pipe smoker. He fought skin cancer from age sixteen, and had several operations to the face. After the death of his mother, Lela Sandlin Alford, in 1958, Henry returned to Groves, Texas, and lived in his mother's old house at 7061 Henry Street until his death. The street was actually named after him. He died of bladder cancer on October 14, 1968 at the Mid-Jefferson County Hospital in Nederland, Texas (Jefferson County). He had been a member of the First Baptist Church of Groves and was a Lion's Club member (obituary in Beaumont Journal). He was truly a good man. Henry was buried at Oak Bluff Cemetery in Port Neches (Jefferson County), Texas. His wife died in 1983.

On March 2, 1930, according to the Port Arthur News, Claudine was named to the Port Neches girl's High School basketball team. As a young woman, Claudine participated in many church activities at Groves Baptist Church. On July 20, 1930, she was chosen as the social director for the church's Young Woman's Association. Around 1936, she married, high school sweetheart, J. Weldon McKnight (9/1/1911-4/1979) in Groves. On October 30, 1938, Claudine and her husband, Weldon, put on a Halloween party for her sisters, Doris and Helen, with over 40 guests. Claudine and Weldon lived in Port Neches/Groves for the rest of their lives. Weldon owned an insurance company and died a millionaire. Claudine died on July 3, 1997 in Jefferson County, Texas. Nothing else is known of this family. Claudine had no natural children but did have one adopted son, Stephen McKnight (?-?).

In 1919, as a young man, Earl moved to Beaumont, Texas (Jefferson County), where he boarded with Thomas Byers (1920 census - listed as Earl "Afford"). His occupation was listed as a policemen. In 1924, William Earl Alford was living in Orange County, Texas,

according to Jefferson County land records. In 1925, Earl met and married Lela Ethel Peck (1906-aft 1930), daughter of Earl and Evelyn Peck of Temple, Texas, in Jefferson County. Shortly after the birth of their son, Earl, Jr., in 1929, the couple moved to Houston, Texas (Harris County), where they lived with Earl's mother, Leila Sandlin Alford, in her boarding house on Pierce Street. They were still there on the 1930 census. At that time he worked as an inspector in a tailoring shop. His wife, Ethel, was a cashier in a shoe shop. In late 1930, William moved his family to New London, Texas, near Overton (Rusk County), where he operated and owned the Alford Grocery Store until his death on May 12, 1953 of a heart attack. On May 26, 1940, Earl visited his mother, Lela Alford, in Groves, Texas. His son, Earl, Jr., age 10, stayed the week. He spent some time with brother, Claude Alford, who was visiting from Aransas Pass, Texas. Mamie Estelle Alford, daughter of Henry Marion Alford, was born in 1904 in Shelby County, Texas (near Teneha). She grew up in Shelby and later in Liberty County, Texas. She moved with her family to Port Neches, Texas (Jefferson County) about 1920. In 1920, Mamie married Claude Lee Duplissey, Sr. (3/25/1899-7/1967) from Montgomery County, Texas; the son of Hezekiah and Mary Duplissey. Mamie and Claude's marriage could have taken place in either Jefferson or Montgomery County, but I have no documentation. From 1923-1925, Mamie and Claude were living in Navarro County, Texas, according to Jefferson County land records. In 1928, Mamie and Claude Lee, an oil well driller by occupation, moved in with Mamie's widowed mother, Lela, at her boarding house in Houston, Texas, where they lived, along with their two sons, until they separated in 1930 by divorce. According to Mamie's grandchildren, alcoholism on both sides had doomed the marriage. Mamie and her two children, Claude Lee, Jr. and Marion Duplissey, continued to live with her mother, Lela Sandlin Alford, after the separation. Claude Lee, Jr. and Marion Duplissey both show on the 1930 census, living with Lela Alford and several cousins, along with their Uncle William Earl Alford. Their paternal Uncle Clyde Duplissey, also lived with the Lela Alford family. Claude Lee, Sr. was found living as a widower (according to the census) in Dayton, Texas (Liberty County) in 1930. He bumped around from place to place for several years before making it big in the oil business. Claude Lee died in Hot Springs, Arkansas in 1967. On July 29, 1936, Mamie, who still went by Mrs. C.L.Duplissey, and her children Claude, Jr. and Marion, visited her brother, Henry Alma Alford, in Groves. Mamie's mother, Lela Alford also lived with Henry Alma at this time. Mamie later married her second husband, Edward Keck (?-?) around 1940. Soon after marriage they settled in Groves, Texas. On June 27, 1941, Mamie was visited in Groves by her son, Marion Duplissey of Houston. Shortly thereafter in 1941, Mamie and Ed Keck moved to Orange for a short time before returning on February 23, 1942, to live with Mamie's mother, Lela Sandlin Alford, in Groves. I do not know much else about her, other than she was living in Seattle, Washington from at least 1952-1965, where she probably died. Her grandson, Claude Vernon Duplissey had told me that he received a call from Seattle, when she was on her death bed. In the summer of 1927, after the death of her father in 1924, her mother moved the family to Houston, Texas (Harris County), where she was living at home (1628 Pierce Ave.) in 1930. In June 1930, Iva Dell eloped to Vinton (Calcasieu Parish), Louisiana and married a young oil worker, Marion Loftin (10/22/1896-12/1973). After marriage, the couple settled in Orange (Orange County), Texas. On July 8, 1930, after a month of marriage, Iva Dell took the train to Houston, to visit her mother. Shortly after arrival, the two ladies went shopping, and arrived back at her mother's home (a boarding house) at about 4:00 PM. Getting ready to return to Orange about 5:00, she told her brother, William Earl, goodbye and asked where Henry Alsup, a longtime friend, boarder of 3 years, and secret admirer was. Lela Alford, Iva Dell's mother ran from the front part of the house screaming, to the dining room. She then ran outside to get help, yelling the owner of the barber shop across the street, "He has killed my child." J.C. Howard, the barber shop owner called the police. Iva Dell's new husband, Marion Loftin, also a friend of Henry Alsup, was notified by phone, and he arrived in Houston about 9:00 PM that night. He spent the next day attending to funeral arrangements. Iva Dell's sister, Smithie Harris, was listed as the informant on her death certificate. She was taken to her birthplace of Teneha, Texas in Shelby County for burial. Her husband, Marion, died in Austin, Texas in 1973, his last residence. Iva Dell is buried next to her husband and mother at Ramah Cemetery in Shelby County near Teneha. Her tombstone reads, "She was the sunshine of her home." Iva Dell and Marion Loftin had no children.

He grew up there, but in 1918 at the age of 15 he got into an argument with his father. His grandson, Paul Orval Alford, told this author that the argument was over his father leaving his mother back in 1908. Samuel, enraged, ran away from home, and at the age of 15, he joined the U.S. Navy where he found himself fighting with British forces in India. After the war, he came back to the United States, where in 1920 (census), he was a patient at the U.S. Marine Hospital in New Orleans, Louisiana. After discharge from the hospital, Murray migrated to the Chicago area, home to some Navy friends. He also spent some time not far away in Elkhart, Indiana, where he met his wife Eleanor Alice Kemp (8/15/1909-12/15/1987 / b. Elkhart, Indiana). They were married in either Chicago or Elkhart in 1928. In around 1929, Murray and his wife moved to St. Louis, Missouri. He was apparently following some friends he had met during the war. One particular friend was a Mafia boss in East St. Louis, Illinois. In 1930 Murray and his wife were living in St. Louis on Chouteau Avenue, where he worked on the railroad. About this time, his wife thought it better that they get away from these friends, fearing getting involved with the Mob. Murray was killed in an automobile accident on April 8, 1935, while driving on Onondoga Lake Boulevard just north of Syracuse in Onondoga County. His wife was injured in the head on collision, with a fractured rib and nose. She was taken to St. Joseph's Hospital, where she was treated and released. Murray was buried in Woodlawn Cemetery in Syracuse. After her husband's death, Ethel and her son moved back to Elkhart, Indiana. She died in 1987 and is buried in Dearborn County, Indiana (Aurora).
