

## Known Descendants of John (1795 England) & Nancy Jones Alford

1. **John Alford** #1 b. estimate 1795, England, m. by 1816, in England, **Nancy Jones** #2, b. estimate 1800, England, d. 1841-1855, Jefferson Co., KY. John died by 1860, Jefferson Co., KY.

His birth date based on birth of first known child. No known census data. Their marriage date based on birth of first known child, Jacob J./I. Alford in 1817. His death based on date of Jefferson Co. KY Will--1855 with Codicil dated 1857. Missing from Jefferson Co. KY Alford's in 1860.

Evidently John and family came to the U.S. about 1825-1830. His family is probably that enumerated in 1840 Jefferson Co., Louisville, as MEG Alford or unreadable. That enumeration is 3210101-111100311, page 110. This enumeration may have included any married children as well as possible boarders or additional family members. His will is dated Sept. 1855 with a Codicil dated 1857. Executors were Jacob J. and James H. Alford. He had eleven children but they were not all named in the will.

**Nancy:** Name is based solely on mother's name on death certificate of James H. Alford. It is possible that there was more than one wife and perhaps once we know the married name several daughters, we can get death certificates for further information, especially that of Mary Elizabeth (youngest child). Her death was based on the youngest child born 1840/1841. She was not mentioned in John's 1855 Will.

**Nannie/Nancy:** Look for estate records for Israel. In 1860, she had \$6000 worth of real estate (her new husband had \$16000). She married Edward G. Taylor, Sept. 14, 1869, Jefferson Co. KY (Book 10, p. 105). Son A. H./Henry is living with them in 1870. He died in 1881 and left his entire estate to his mother, Nancy Taylor.

Robert was also the informant on his father's death certificate. Ben and Amelia were not living together from 1900 on (based on census records only). Evidence from relative of a possible second wife--Charlotte Seymour. Amelia's brother Robert was also a druggist according to 1880 Jefferson Co. KY census.
