1794 Mar 27 - p. 152 Robert Young vs. George Alford in debt. Jury found that deft. does not owe the debt and plff. for his false clamour is to pay costs. Ordered George Alford to pay Edward Barrett 361 cents for 7 days attendance as witnesss for him vs. Young.

1798 Oct 31 - p. 231 - George Alford vs. John Cails for 4-14-6 due by note, same.

1818 Nov 24 - p. 283 - Deed from Henry Alford & wife Eleanor to

Thos. Corrough for 100 acres in Monroe County.

1819 Aug 25 - p. 294 - Deed from John Bowman & Henry Alford admitted to record.

1820 Mar 28 - p. 302 - Memorial of deeds from Henry Alford to James & Robert Alford for 235 acres on Muddy Creek mountian admitted to record.

1820 July 25 - p. 312 - Shaffer v. Sydenstrucker. William Wilson, assignee of Henry Alford, defendant.

1821 May 22 - p. 321 - John Aldeson appointed surveyor of road from Greenbrier River to lands of James Jarrett, Jr, Among them is Henry Alford & hands.

1821 Aug 17 - p. 323 - Trial of Henry, a slave, accused of stealing a horse belonging to Henry Alford; found not guilty.
